
Dear Mr. Donovan:

ORDINANCE NO. 122

An Ordinance Annexing Part of Block 12 of
Lakeview (now vacated) to the Village of
Mahtomedi, Minnesota.

THE VILLAGE COUNCIL OF THE VILLAGE OF MAHTOMEDI DO SOLEMNLY AS FOLLOWS:

Section 1. That pursuant to that certain petition signed by all the owners of the land hereinafter more particularly described in Washington County, Minnesota, containing less than two hundred acres, abutting upon land of the Village of Mahtomedi, requesting the annexation of said land to said Village, said petition having been duly filed with the Clerk of said village; and it appearing that such annexation will be to the best interests of the village and of the territory affected, the village boundaries of the Village of Mahtomedi are hereby extended to include the following described land, in Washington County, Minnesota, to-wit:

That part of Government Lots One (1) and Two (2) in Section Twenty-nine (29) North, Range Twenty-one (21) West in Washington County, Minnesota, described as follows, to-wit:

Beginning at a point on the West line of Fairmount Avenue 509 feet South of Arbor Street; thence West on a line parallel to the South line of said Arbor Street to the East line of former Minneapolis, St. Paul Suburban Railway right-of-way; thence South along the East line of said right-of-way to the center line of Forest Street (also known as Dehlie Street); thence East along the center line of said Forest Street to the center line of Fairmount Avenue; thence North along the center line of Fairmount Avenue to a point due East of the point of beginning; thence due West to point of beginning, (being part of Block 12 of Lakeview, now vacated).

and that said territory is hereby made a part of the Village of Mahtomedi as effectually as of the same had originally been a part of said village.

Section 2. This Ordinance shall take effect and be in force upon the filing of a certified copy thereof with the County Auditor of Washington County, the Secretary of State of the State of Minnesota and with the State Municipal Commission on annexation and consolidation, and from and after its publication.
