THE VILLAGE COUNCIL OF THE VILLAGE OF MARTINERI DO COTAIN AS FOLICES:

Section 1. That purrount to that certain potition signed by all the owners of the land horeinafter more carticularly described in Esshington County, Minnesota, containing less than two hundred acres, abutting upon land of the Village of Mahtomedi, requesting the annexation of said land to said Village, soid edition baving book only filed with the Clark of soid village; and it against hat such annoxation will be to the best interests of the village and of the territory affected, the village boundaries of the Village of Mahtomedi are hereby extended to include the following described land, in Washington County, Minnesots, to-wit:

> That part of Government Lots One (1) and Two (2) in Section Twenty-nine (29) North, Range Twentyone (21) West in Mashington Sounty, Minnesota, described as follows, to-wit:

Beginning at a point on the West line of Fairmount Avenue 509 feet South of Arbor Street; thence West on a line parallel to the South line of said Arbor Street to the Mast line of Corner Minneauolis, St. Paul Suburban Reilway right-of-way; thence South along the Mast line of said right-of-way to the center line of Forest Street (also known as Dahlia Street*; thence Hash along the center line of said Forest Street to the center line of Tairmount Avenue; thence Worth along the centor line of Fairmount Avenue to a point due Last of the point of beginning; thence due West to point of beginning, (being part of Block 12 of Lakoview, now vacated).
