

ORDINANCE 46

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF ST. BONIFACIUS, HENNEPIN COUNTY, MINNESOTA TO INCLUDE CERTAIN UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA.

Whereas, a certain petition dated July 10, 1959, requesting annexation of the territory described below was duly presented to the council on the 10th day of July, 1959; and

Whereas, the petition is signed by all the owners of the land thereby affected:

The Council of the Village of St. Bonifacius hereby ordains:

Section 1. Declaration. It is hereby determined that the territory described below abuts upon the Village and is so conditioned as properly to be subjected to village government.

Section 2. Territory annexed. The corporate limits of the Village of St. Bonifacius are hereby extended to include the territory described as follows: That part of the Northeast Quarter of Section 31, Township 117, Range 24, described as follows: Commencing at the intersection of the East line of said Section 31 and the center line of the new State Highway No. 7; thence South along the East line of said Section a distance of 305.9 feet to a point on said East line which is 1697.5 feet South of the Northeast corner of said Section; thence at an angle to the right of 89 degrees, Forty (40) minutes a distance of 476.2 feet to a point at which there is an iron monument; thence at an angle to the right of 88 degrees, a distance of 333 feet, more or less, to the center line of said new State Highway No. 7; thence Easterly along the center line of said new State Highway No. 7 to the point of beginning, all of said land being in Hennepin County, Minnesota.

Section 3. Filing. The Village Clerk is hereby directed to file certified copies of this ordinance in the office of the Municipalities Commission, in the office of the Secretary of State and in the office of the County Auditor of Hennepin County.

Section 4. Effective date of Annexation. Annexation shall be complete from and after the date when certified copies of this ordinance have been filed as directed in Section 3.




