Section 1. Declaration. It is hereby determined that the territory described below abuts upon the Village and is so conditioned as properly to be subjected to village government.

Section 2. Territory amened. The corporate limits of the Village of St. Bonifacius are hereby extended to include the territory described as follows:

That part of the Northeast Quarter of Section 31, Township 117, Range 24, described as follows: Commencing at the intersection of the Bast line of said Section 31 and the center line of the new State Highway No. 7; thence South along the Bast line of said Section a distance of 305.9 feet to a point on said Bast line which is 1697.5 feet South of the Northeast corner of said Section; thence at an angle to the right of 89 degrees, Forty (40) minutes a distance of 476.2 feet to a point at which there is an iron monument; thence at an angle to the right of 88 degrees, a distance of 333 feet, more or less, to the center line of said new State Highway No. 7; thence Easterly along the center line of said new State Highway No. 7; thence Easterly along the center line of said new State Highway No. 7; thence Easterly along the center
