
Dear Mr. Donovan:

of going through the Municipal Commission on Annexation.


I am pursuant to said Chapter 686, forwarding a copy also



Ordinance No. 129

In compliance with the laws and provisions of
Minnesota's Statutes to read of the Village of
the Village of Mahtomedi, Minnesota.

THE VILLAGE BOARD OF THE VILLAGE OF MAHTOMEDI, MINNESOTA:

Section 1. That pursuant to that certain petition signed by all the
owners of the land herein described particularly described in Washington
County, Minnesota, containing less than two hundred acres, abutting upon land
of the Village of Mahtomedi, requesting the annexation of said land to said
Village, said petition having been duly filed with the Clerk of said Village;
and it appearing that such annexation will be to the best interests of the
village and of the territory affected, the village boundaries of the Village
of Mahtomedi are hereby extended to include the following described land, in
Washington County, Minnesota, to-wit:

Commencing at the intersection of the center
lines Hanson Street and Griffin Street; thence
East along the center line of Hanson Street to
the center line of Hallam Street; thence South
along the center line of Hallam Street to the
center line of Woodland Street (also known as
Iris Street); thence West along the center line
of said Woodland Street to the center line of
Griffin Street; thence Northwardly along the center
line of Griffin Street to the point of beginning.

and that said territory is hereby made a part of the Village of Mahtomedi as
effectually as if the same had originally been a part of said Village.

Section 2. This Ordinance shall take effect and be in force upon the
filing of a certified copy thereof with the County Auditor of Washington County,
the Secretary of State of the State of Minnesota and with the State Municipal
Commission on annexation and consolidation, and from and after its publication.
