ORDINANCE NO. 130

An Ordinance Annexing the Westerly Part of Lot  
1 of Town of East Shore to the Village of  
Mahtomedi.

THE VILLAGE COUNCIL OF THE VILLAGE OF MAHTOMEDI DO ORDER AS FOLLOWS:

Section 1. That pursuant to that certain petition signed by all of the owners of the West 269.44 feet of Lot One (1) of the Town of East Shore according to the recorded plat thereof, excepting the West 50 feet of the North 100 feet thereof measured along the West side of said Lot and which exception is not included in the tract hereinafter more particularly described, in Washington County, Minnesota, containing less than two hundred acres, abutting on three sides thereof upon the Village of Mahtomedi, requesting the annexation of said land to said Village, said Petition having been duly filed with the Clerk of said Village; and it appearing that such annexation will be to the best interests of the Village and of the territory affected, the Village boundaries of the Village of Mahtomedi are hereby extended to include said land described by the following boundary lines:

Commencing at a point on the center line of Griffin Street which point is 100 feet South of the Northwest corner of Lot One (1), Town of East Shore measured along the West line of said Lot; thence East parallel to the South line of said Lot to a point which is 50 feet East of the West line of said Lot; thence North parallel to the West line of said Lot to the Southerly right-of-way line of the Northern Pacific Railway; thence Easterly along said Southerly right-of-way line to a point which is 269.44 feet East of the West line of said Lot measured along a line parallel to the South line of said lot and which point is the Northwest corner of the tract of land annexed to the Village of Mahtomedi by Ordinance No. 108 of said village; thence South along the West line of said tract of land so annexed by said Ordinance No. 108, said line being 269.44 feet East of the West line of said Lot, to the center line of Maple Street; thence West along the center line of Maple Street to the Center line of Griffin Street; thence North along the center line of Griffin Street to the point of beginning.

and that said territory is hereby made a part of the Village of Mahtomedi as effectually as if the same had originally been a part of said Village.

Section 2. This Ordinance shall take effect and be in force upon the filing of a certified copy thereof with the County Auditor of Washington County and the Secretary of State of the State of Minnesota and with the State Municipal Commission on Annexation, from and after its publication.
