Dear Sir: Re: Annexation of territory to Clarkfield, Minn.

The Village Clerk has brought in your letter of July 24th, returning the certified copy of Ordinance annexing territory in SW $\frac{1}{4}$ SE $\frac{1}{4}$ Sec. 4, 115,41, to Clarkfield. You refer us to the new annexation code.

AN ORDINANCE RELATIVE TO THE ANNEXATION OF CERTAIN LANDS IN THE
SOUTHWEST QUARTER OF THE EAST HALF OF SECTION FOUR,
TOWNSHIP 115 NORTH, RANGE 41 WEST OF THE 5th DISTRICT, MINNESOTA

Whereas, the owners of all the lands hereinafter described have joined
in a petition for the annexation to and inclusion within the village of said
lands, and

Whereas, said lands are found to abut on the village of Clarkfield,
and are not included within any other municipality, and are unplotted and
contain less than 200 acres; said lands are also found to be so conditioned

to be for the best interests of the village of Clarkfield and of the
territory affected that it be annexed,

Therefore:

The Village Council of Clarkfield Ordains:

1. These tracts of land described as follows, to-wit:

A parcel of land in the SW $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 4, Township 115 North, Range 41
West; more particularly described as follows: Beginning at a point on the
west line of the east one-half of section 4, Township 115 north, Range 41
West, a distance of 175 feet north of the southwest corner of the SE $\frac{1}{4}$ of
said Section 4; thence continue north along the west line of the east one-
half of said Section 4 a distance of 429.4 feet to the south line of the
proposed Velde's First Addition to the Village of Clarkfield, Minnesota; thence east along the said south line of said proposed Velde's First Addition
a distance of 336.65 feet to the west line of Alice Street as platted in
said Proposed Velde's First Addition; thence south along an extension of the
west line of Alice Street, a distance of 270 feet; thence west at right
angles a distance of 105 feet; thence south at right angles a distance of
158.9 feet; thence east a distance of 42.0 feet; thence south a distance
of 35.7 feet to a point that is 150 feet north of the south line of said
Section 4; thence south 150 feet to the south line of said Section 4, this
point being a distance of 260.5 feet east of the southwest corner of the
SE $\frac{1}{4}$ of said Section 4; thence west along the south line of said Section 4
a distance of 116.2 feet; thence north 181.5 feet; thence west 161 feet to

Addition; thence north at right angles a distance of 580 feet; thence west
a distance of 387.02 feet to the west line of the east one-half of said
Section 4; thence south along the west line of the east one-half of said
Section 4 a distance of 580 feet to the point of beginning, which tract is
the proposed Velde's First Addition to the Village of Clarkfield, Minnesota,
and which tract adjoins and has a common boundary with the other tract of
land included in this petition and described immediately above,

are hereby annexed to and included within the Village of Clarkfield, Minnesota.
