



ORDER

The Village of Shorewood has, by resolution of the Village Council at a regular meeting held on July 14, 1959, petitioned for the detachment of certain property hereinafter described and the Village of Excelsior has concurrently, by resolution of the Village Council at a regular adjourned meeting held on July 20, 1959, petitioned to annex the same territory, all pursuant to Chapter 686, Minnesota Laws of 1959, Section 6(2).

The territory involved consists of

The Northeasterly 475 feet of Lots 117 and 118,
Auditor's Subdivision Number One Hundred and
Twenty, Hennepin County, Minnesota, according
to the recorded plat thereof.

All of the territory involved is the property of the Church of St. John the Baptist of Excelsior, Minnesota. The sole owner has consented in writing to the simultaneous detachment from the Village of Shorewood and annexation to the Village of Excelsior.

All of the requirements of the statute having been met,

IT IS ORDERED: That the above described real property be, and it hereby is, detached from the Village of Shorewood and annexed to the Village of Excelsior, the same as if it had originally been a part thereof.
