



ORDINANCE NO. 303

AN ORDINANCE TO ANNEX CERTAIN PROPERTY TO THE CITY OF
WORTHINGTON, MINNESOTA.

THE CITY COUNCIL OF THE CITY OF WORTHINGTON, DO ORDAIN:

NOW, WHEREAS, Pursuant to Section 414.03 and all amendments thereto, of Minnesota Statutes for 1959, all owners of property hereinafter described and abutting upon the City of Worthington, have petitioned the City Council of said City of Worthington to have such property annexed to said City; and

WHEREAS, It is desired that said territory become a part of said City of Worthington, the same as if it had been originally a part thereof;

NOW, THEREFORE, The following described territory is hereby declared to be a part of the City of Worthington; to-wit,

That part of the Northeast Quarter (NE $\frac{1}{4}$) of Section 26, Township 102 North, Range 40 West, Nobles County, Minnesota, described as follows:

Commencing at the Northeast corner of said Section, thence West along said Section line 33 feet, thence South along the West line of County Road No. 9, 1732 feet, which is the point of beginning, and which point is on the existing City Limits line of the City of Worthington; thence Westerly along the existing City Limits line a distance of 107 feet; thence North 90 degrees a distance of 100 feet; thence East and parallel to the City Limits line a distance of 160 feet to a point on the West line of County Road No. 9, thence Southwesterly along the West line of County Road No. 9 a distance of 110 feet to the point of beginning.
