**Ordinance No. 174**

AN ORDINANCE ANNEXING  
CERTAIN PROPERTY TO THE  
VILLAGE OF HERON LAKE,  
MINN.

THE VILLAGE COUNCIL OF  
THE VILLAGE OF HERON  
LAKE, MINNESOTA, DO OR-  
DAIN:

Section 1

That upon the receiving and  
filing of the Petition of Andrew  
H. Hanson, the sole owner of  
the real property hereinafter  
described, it is hereby found and  
declared that the annexation of  
the said property to the Village  
of Heron Lake, Minnesota, is to  
the best interest of this Village  
and of the said territory affect-  
ed.

Section 2

That the following described  
territory is hereby declared an-  
nexed to the said Village of  
Heron Lake, in Jackson Coun-  
ty, State of Minnesota, pursuant  
to the provisions of the Laws  
of the State of Minnesota, for  
the year 1959, Chapter 686, Sec.  
3, Subdivision 7, to-wit:

Part of the Southwest Quarter  
of Section 20, Township 104  
North, Range 37 West of the  
5th P. M., County of Jackson,  
State of Minnesota, described as  
follows: Commencing at the  
southwest corner of Section  
20, thence north 1133 feet and  
east 33 feet to the point of  
beginning; thence North 570  
feet; thence east 300 feet;  
thence south 570 feet; thence  
west 300 feet to the point of  
beginning.

The above described property  
to be designated in the Plat to  
be filed in the Office of the  
Register of Deeds in and for  
Jackson County, Minnesota, as  
"Hanson's Second Addition to  
the Village of Heron Lake".
