ORDINANCE NO. 31.00

AN ORDINANCE RELATING TO THE ANNEXATION OF CERTAIN  
TERRITORY TO THE VILLAGE OF CHANHASSEN, MINNESOTA

The Village Council of the Village of Chanhassen, Minnesota,  
ordains:

SECTION 1. ANNEXATION. That the land hereinafter described in Section 2 hereof, the Village Council having determined that the annexation thereof is to the best interests of the village and to the territory affected, is hereby annexed to the included within the boundaries of the Village of Chanhassen pursuant to petition of the sole owner of said land and after considering the matter, pursuant to Subdivision 7, Section 3, Chapter 686, Laws of 1959.

SECTION 2. DESCRIPTION OF LAND ANNEXED. That the land hereby annexed is situated in Carver County, Minnesota, and is described as follows, to-wit:

That part of Section 12, Township 116, Range 23 described as follows: Commencing at the Southeast corner of the Southeast 1/4 of the Southwest 1/4 of said section; thence West along the South line of said Southeast 1/4 of Southwest 1/4 a distance of 675.3 feet to the East line of the West 1/2 of said section, being the point of beginning of land to be described; thence North along the said East line of the West 1/2 of said section a distance of 1328.82 feet to the North line of the Southeast 1/4 of the Southwest 1/4 of said section; thence West along said North line a distance of 667.4 feet to the West line of said Southeast 1/4 of the Southwest 1/4; thence South along said West line a distance of 1045.8 feet; thence East and parallel with the South line of said Southeast 1/4 of the Southwest 1/4 a distance of 640.9 feet; thence South and parallel with said East line of the West 1/2 of said Southeast 1/4 of the Southwest 1/4 a distance of 283 feet to the South line of said Southeast 1/4 of the Southwest 1/4; thence West on the South line of said Southeast 1/4 of the Southwest 1/4 a distance of 33 feet to the point of beginning.

SECTION 3. CERTIFIED COPIES TO BE FILED. The Clerk is hereby directed to file certified copies of this ordinance in the office of the Auditor of Carver County and in the office of the Secretary of State of the State of Minnesota and in the office of the Municipal Commission.

SECTION 5. REPEALER. Ordinance 31, an ordinance relating to the annexation of certain territory to the Village of Chanhassen passed May 20, 1959 is repealed.
