ORDINANCE NO. 157

RELATING TO THE ANNEXATION OF CERTAIN PROPERTY  
TO THE CITY OF ALEXANDRIA, MINNESOTA

THE CITY COUNCIL OF THE CITY OF ALEXANDRIA, MINNESOTA, DOES ORDAIN:

SECTION I. The corporate limits of the City of Alexandria, Minnesota, shall be extended to include and encompass the lands and territory hereinafter described in Section II, III and IV hereof, the lands and territory described in Section II hereof now being owned by the City of Alexandria; the lands and territory described in Section III hereof now being owned by the Production Credit Association of Alexandria, and Edgar D. Engstrom, Clifford E. Engstrom, Edwin H. Engstrom, and Leslie F. Engstrom of Alexandria, Minnesota; and the lands described in Section IV hereof being owned by the Independent School District No. 206 of Douglas County, Minnesota, and all of such land lying immediately adjacent and abutting upon the corporate limits of the City of Alexandria, Minnesota, and the owners of the land described in Section III and IV hereof having petitioned that said land be included within corporate limits of the City of Alexandria and annexed thereto.


SECTION II. (A) All that part of the Northwest Quarter of Section Thirty, Township One Hundred Twenty Eight, Range Thirty Seven, lying outside of the corporate limits of the City of Alexandria, and east of the east line of Bryant Street extended in a southerly direction, west of the east line of Fillmore Street extended in a southerly direction to a point of intersection with the northerly line of the South Sixteen acres of the East Twenty Acres of said northwest Quarter of Section Thirty, north of said line of the South Sixteen line of the East Twenty Acres of said Northwest Quarter extended in a westerly direction to its point of intersection with the Northwesterly right of way line of Trunk Highway 29, Northwesterly of the Northwesterly right of way line of said Trunk Highway No. 29 and north of the northerly property line of the present Alexandria Municipal Airport (said northerly line of the present Alexandria Municipal Airport being a part of the City Limits of the City of Alexandria.)

(B) All that part of the South Half of the Southwest Quarter of the Northwest Quarter of Section Seventeen, Township One Hundred Twenty Eight North, Range Thirty Seven-West, lying East of the centre line of Old Trunk Highway No. 29; (now being partly Trunk Highway No. 29 and partly County Aid Road No. 9).

SECTION III. The South Sixteen Acres of the East Twenty Acres of the Northwest Quarter of Section 30, Township 128, Range 37.

SECTION IV. That portion of the Northwest Quarter of the Northwest Quarter of Section Twenty Nine, and of the Northwest Quarter of Section Thirty, lying between the present corporate limits of the City of Alexandria, and the hereinafter described line, to wit: Commencing at the Section Corner common to Section 19, 20, 29, and 30, going thence south along the section line between sections 29 and 30 a distance of 100.39 feet to the point of intersection of such Section line with the westerly line of County Aid Road No. 23, thence southeasterly at an angle of  $28^{\circ} 38'$  with said section line and along the southwesterly right of way limits of said County Aid Road, a distance of 473.7 feet, thence south  $41^{\circ} 52'$  west, 291.3 feet, thence south  $88^{\circ} 40'$  west 1496.10 feet more or less to the point of intersection of said line with the present corporate limits of the City of Alexandria.


SECTION V. All said lands and territories described by limits, descriptions and boundaries in Section II, III, and IV above, are hereby annexed to and made a part of the City of Alexandria, Minnesota.

SECTION VI.

Said property above described by limits, descriptions and boundaries, shall be and become a part of the following wards of the City of Alexandria:-

(a) That part described in Section II (A), shall be and become a part of the Fifth Ward of the City of Alexandria.

(b) That part described in Section II(B) shall be and become a part of the Second Ward of the City of Alexandria.

(c) That part described in Section III and IV shall be and become a part of the Fourth Ward of the City of Alexandria.

SECTION VII.

This ordinance shall take effect from and after its due passage and publication in accordance with the laws of the State of Minnesota and the Charter of the City of Alexandria.
