ORDINANCE NO. 126

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF CAMBRIDGE, ISANTI COUNTY, MINNESOTA, TO INCLUDE UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA

WHEREAS, a certain petition requesting annexation of the territory described below was duly presented to the council on the 10th day of August, 1959; and

WHEREAS, said petition was duly signed by the sole owner of said territory;

THE VILLAGE COUNCIL OF CAMBRIDGE ORDAINS:

Section 1. Declaration. It is hereby determined that the territory described below abuts upon the village and is so conditioned as properly to be subjected to village government.

Section 2. Territory Annexed. The corporate limits of the village are hereby extended to include the territory described as follows:

All that part of the following described tract of land lying to the East of the right-of-way of the Eastern Railway Company of Minnesota, (now the Great Northern Railway Company), to-wit: Being a Sub-division of the Northwest Quarter (NW $\frac{1}{4}$) of Section 28, Township 36, Range 23; Commencing on the quarter line running North and South through the Northwest Quarter (NW $\frac{1}{4}$) of Section 28, Township 36, Range 23, at the Northeast corner of land owned by Olof Bergman in said Northwest Quarter (NW $\frac{1}{4}$), it being about 42.17 rods North of the Southeast corner of said Northwest Quarter (NW $\frac{1}{4}$), thence West following the North line of said Bergman's land across the right-of-way of the Eastern Railway Company of Minnesota, about 106 rods to the center of the main traveled road, thence in a Northerly direction following the center of said road to the South line of the land owned by Hans J. Gouldborg in said Northwest Quarter (NW $\frac{1}{4}$), thence East following the South line of said Gouldborg's land across said right-of-way about 94 rods to said quarter line, thence South following said quarter line to point of beginning, except land conveyed to the Eastern Railway Company of Minnesota for right-of-way purposes.

That part of the Southeast Quarter of the Northwest Quarter (SE $\frac{1}{4}$ of NW $\frac{1}{4}$) of Section 28, Township 36, Range 23, described by notes and bounds as follows, to-wit: Commencing at the center post of said Section 28, running North on the quarter line 42 rods, thence West parallel with the quarter line on the South side until it intersects with the right-of-way of the Eastern Minnesota Railway, thence following the said right-of-way in a southwesterly direction to the quarter line, thence running East on the quarter line to the starting point, containing 13 acres, more or less.

Section 3. Filing. The village clerk is hereby directed to file certified copies of this ordinance in the office of the secretary of state, in the office of the Municipal Commission established by Laws 1959, Chapter 686, and in the office of the county auditor of Isanti County, Minnesota.
