VILLAGE ORDINANCE NO. 37

An Ordinance Extending the Village Boundaries of the Village of Taconite, Itasca County, Minnesota, So As to Include Within the Village and to Annex thereto All of the Northwest Quarter of the Northeast Quarter of Section Twenty-seven, Township Fifty-six North, Range Twenty-four West, Itasca County, Minnesota, except Outlot No. One of Auditor's Subdivision No. One.

The Village Council of the Village of Taconite do ordain as follows:

Section 1 -

A majority of the owners of all of the Northwest Quarter (NW 1/4) of the Northeast Quarter (NE 1/4) of Section Twenty-seven (27), Township Fifty-six (56) North, Range Twenty-four (24) West, Itasca County, Minnesota, except Outlot No. One (1) of Auditor's Subdivision No. One (1), having Petitioned the Village Council of the Village of Taconite to have said land included within said Village and annexed thereto; and this Council having heretofore held a public hearing on the proposed annexation after more than thirty (30) days posted notice thereof; and this Council having determined and does hereby determine that the territory to be annexed to said Village is so conditioned as to properly be subject to municipal government and does further determine that the annexation will be for the best interests of the Village of Taconite and of the territory affected.

It is hereby ordained, enacted and declared that said tracts of land above described be and the same are hereby annexed to the said Village of Taconite, and the boundaries and corporate limits of said Village of Taconite are hereby extended so as to include said tracts of land, and said lands shall be and become a part of said Village as effectually as if they had been originally a part thereof.

Section 2 -

This Ordinance shall take effect and be in force from and after its passage and publication and the filing of a certified copy thereof with the Municipal Commission of the State of Minnesota and with the County Auditor of Itasca County, Minnesota, and with the Secretary of State of the State of Minnesota.

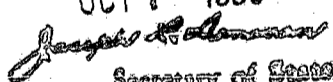
