WHEREAS, a certain petition dated September 29th, 1959, re-questing the annexation of the territory described below was duly presented to the Council on the 29th day of September, 1959, which petition was signed and verified by all of the owners of such property; and,

WHEREAS, The Council has duly considered such petition and all matters therein stated; the all matters therein statea; Village Council of the Village of T. Sueur County, Kilkenny in Le Sueur County, Minnesota do now ordain as follows:

Section 1. Declaration. It is hereby determined that the terri-tory described below abuts upon the village and is so conditioned as property to be subjected to village government. Section 2.

Section 2. Territory Annexed. The corporate limits of the village are hereby extended to include the territory described as follows:

Beginning at a point 765.10 feet North and 135.00 feet West of the South One Quar-ter Corner of Section No.22, Township No. 110 North, Range 23 West, Le Sueur County, Minnesota, said point being on the West line of Lakeview Avenue of Mc-Dermott's Addition to the Village of Kilkenny, Thence Wast 576 05 fact thereas West 676.05 feet, thence South 11 degrees and 27 min-utes East 343.83 feet more or less to the center State Aid Road No. 21 (com-bown as Dodd monly known as 'Dodd Road'), thence Northerly and Easterly along the center line of said road to the North and South center line

inafter stated; that for more than one year prior to the publication therein of the Ordinance No. 28
