ORDINANCE NO. 7

WHEREAS, a Petition signed by all of the owners of the heroinafter described territory has been filed with the governing body of the Village of Sunfish Lake, Minnesota, seeking the amenation of the following described territory to the Village of Sunfish Lake, to wit:

Beginning at the Northeast corner of the Northeast quarter (\$\frac{1}{2}\$) of the Southeast quarter (\$\frac{1}{2}\$) of Section thirty-one (31), Township twenty-eight (28), Range twenty-two (22), thence West on the North line of said Northeast quarter (\$\frac{1}{2}\$) of the Southeast quarter (\$\frac{1}{2}\$) of the Southeast quarter (\$\frac{1}{2}\$) of said Section thirty-one (31), 360 feet to the north line of the Salem Church cross road, thence in a south-easterly direction along the present north line of the said Salem Church cross road to a point on the east line of said Section 285 feet to the place of beginning, thence north on the east line of said Section 285 feet to the place of beginning, containing 1/24 acres more or less, and

WHEREAS said territory:

- (a) is unplatted and does not exceed two hundred (200) nores in area;
- (b) abuts upon and is contiguous to the said Village of Sunfish Lake;
- (c) is not now included in any municipality; and
- (d) is so conditioned as properly to be subjected to municipal government; and

UMEREAS this Council has determined that annexation of the above described territory to the Village of Sunfish Lake will be to the best interests of said Village and of the said territory;

MOW THEREFORE, the Council of the Village of Sunfish Lake does ordain:

SECTION I

That the following described torritory is declared to be unnexed to the Village of Sunfish Lake, to wit:

Beginning at the Mortheast corner of the Northeast quarter $(\frac{1}{6})$ of the Southeast quarter $(\frac{1}{6})$ of Section thirty-one (31), Township twenty-eight (28), Range twenty-two (22), thence West on the North Line of said

Mortheast quarter (2) of the Southeast quarter (3) of said Section thirty-one (31), 380 feet to the north line of the Salem Church cross road, thence in a southeasterly direction along the present north line of said Salem Church cross road to a point on the east line of said Section 285 feet south of the place of beginning, thence north on the east line of said Section 285 feet to the place of beginning, containing 1/24 acres more or less.

SECTION XI.

That the annexation herein provided shall be desmed final upon filing a copy of this Ordinance with the County Auditor for Dakota County, Minnesota, the Manesota Secretary of State, and the Commission created by the Laws of Minnesota, 1959, Chapter 686, Section 1.
