I understand the situation now, and this situation will work itself out I am sure to everyone's satisfaction if you accent the enclosed affidavit inasmuch as the Municipal Commission was willing to accept an affidavit regarding the annexation ordinances, I trust you will do likewise.

I apologize for the inconvenience but trust that $I$ can correct the matter to your satisfaction by the enclosed affidavit.
