An Ordinance Annexing Certain Territory to the City of Willmar to be Known as PALM'S ADDITION TO THE CITY OF WILLMAR, and Extending the Corporate Limits to Include said Property.

(Adopted pursuant to Laws 1959, Chapter 686, Section 3, Subdivision 7, paragraph 4.)

Section 1. A petition has been filed with the City Council of the City of Willmar, Minnesota, by the sole owner or all of the owners in number of the following described real estate to have such sand included within the City of Willmar, Minnesota, which land is described as follows:

That part of the Northwest Quarter (NW 1/4) of Section Twenty Two (22), Township One Hundred Nineteen (119), Range Thirty Five (35), described by metes and bounds as follows: Beginning at a point Five Hundred Twenty Eight (528) feet west and Thirty Three (33) feet south of the Northeast corner of the said Northwest Quarter (NW 1/4), thence south on a line parallel with the east line of the said Northwest Quarter (NW 1/4) a distance of Four Hundred Thirty Three (433) feet, thence west on a line parallel with the north line of the said Section Twenty Two (22), a distance of Two Hundred Forty Seven and fivetenths (247.5) feet, thence north on a line parallel with the east line of the said Northwest Quarter (NW 1/4) a distance of Two Hundred (200) feet, thence east on a line parallel with the north line of the said Section Twenty Two (22), a distance of One Hundred Ninety Seven and five-tenths (197.5) feet, thence north on a line parallel with the east line of the said Northwest Quarter (NW 1/4) a distance of Two Hundred Thirty Three (233) feet, thence east on a line parallel with the north line of the said Section Twenty Two (22) a distance of Fifty (50) feet to the point of beginning.


Section 2. The quantity of land embraced within the foregoing description, and bounded as described, is _______acres.

Section 3. The City Council hereby determines:

- (1) That the annexation will be to the best interest of the City of Willmar, Minnesota, and of the territory affected;
- (2) That the territory described herein abuts upon the City and is so condition as properly to be subjected to City government.

Section 4. The corporate limits of the City are hereby extended to include the property described in Section 1 hereof, and the same is hereby annexed to and included in the City as effectually as if it had originally been a part thereof.

Section 5. The City Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, the County Auditor of the County of Kandiyohi, and the Secretary of State of the State of Minnesota.



Section 6. The said property, upon the taking effect of this Ordinance, as described in Section 1, having been heretofore platted, shall hereafter be known as "PALM'S ADDITION TO THE CITY OF WILLMAR".

Section 7. This Ordinance takes effect upon its passage and publication and the filing of the certified copies as directed herein.




First Reading October 7, 1959
