CHAPTER 19.02

An Ordinance annexing Certain Adjacent and Abutting Real Property to the Village of Buffalo.

That upon the petition of a majority of the owners of the following described real estate and pursuant to hearing held upon 30 days posted notice, whereat it was determined that it will be to the best interest of the Village of Buffalo and the territory hereinafter described that said territory be annexed to the Village of Buffalo, the Village Council of Buffalo do ordain:

Section 1. That the following described platted, and unplatted real estate, not exceeding 200 acres, and adjacent to and abutting upon the said Village of Buffalo, in the County of Wright and State of Minnesota, described as follows, to-wit:

Lots Six (6) through Thirty-five (35), inclusive, of the West Half of the Northwest Quarter of Section Twenty-nine (29), in Township One Hundred Twenty (120), of Range Twenty-five (25), according to the plat thereof on file and of record in the Office of the Register of Deeds in and for Wright County, Minnesota, excepting that part of Lots Six (6), Thirty-one (31), Thirty-two (32), Thirty-three (33), Thirty-four (34), and Thirty-five (35) lying within the corporate limits of the Village of Buffalo; that part of the Northwest Quarter of the Northwest Quarter of Section Twenty-nine (29), in Township One Hundred Twenty (120), of Range Twenty-five (25), lying Easterly of the corporate limits of the Village of Buffalo and excluding the lots designated in the foregoing plat; the Southwest Quarter of the Northwest Quarter of Section Twenty-nine (29), in Township One Hundred Twenty (120), of Range Twenty-five (25), lying Easterly of the corporate limits of the Village of Buffalo, including platted portions thereof; the Southwest Quarter of the South east Quarter of the Northwest Quarter of Section Twenty-nine (29), in Township One Hundred Twenty (120), of Range Twenty-five (25); that part of the Southwest Quarter of Section Twenty-nine (29), in Township One Hundred Twenty (120), of Range Twenty-five (25), lying Easterly of the corporate limits of the Village of Buffalo and lying Westerly of Trunk Highway No. 55, and Northerly of the Buffalo-Hanover road; the East 14.88 chains of the West 20.39 chains of the Southwest Quarter of the Southwest Quarter lying South of the Buffalo-Hanover road of Section Twenty-nine (29), in Township One Hundred Twenty (120), of Range Twenty-five (25),

be and the same is hereby annexed to the Village of Buffalo and shall become a part thereof as effectually as if it had been originally a part thereof.

Section 2. That the annexation of the territory described above shall be determined final upon filing of a copy of the ordinance with the Municipal Commission of the State of Minnesota, the Secretary of State of the State of Minnesota,

and the County Auditor of Wright County, Minnesota.
