An Ordinance Annexing Certain Adjacent and Abutting Real Property to The Village of Buffalo.

That upon the separate petitions of all of the owners of the following described real estate, it appearing to the best interest of the Village of Buffalo and of the territory hereinafter described, the Village Council of Buffalo do ordain:

Section 1. That the following described unplatteed real estate, not exceeding 200 acres, and adjacent to and abutting upon the said Village of Buffalo in the County of Wright and State of Minnesota, described as follows, to-wit:

Commencing at the South quarter corner of Section Nineteen (19), in Township One Hundred Twenty (120) North, of Range Twenty-five (25) West; thence North along the quartor line of said section a distance of 33 feet to the North line of Eighth Street Northwest in the Village of Buffalo for a point of beginning; thence South 89°12' West along the North line of said street a distance of 1301.2 feet; thence due North a distance of 1286.76 feet to the East and West 1/16 line of the Southwest Quarter of said Section Nineteen (19); thence North 89°32' East along the said 1/16 line to the Southwest right of way line of the Minneapolis, St. Paul, & Sault Ste. Marie Railroad Company; thence Southeastly along said railroad right of way line to the East line of the Southwest Quarter of said Section Nineteen (19); thence South along the said East line of said Southwest Quarter of said Section Nineteen (19) to the point of beginning, excepting therefrom that part thereof now lying within the corporate limits of the Village of Buffalo; also that part of the Southeast Quarter of Section Nineteen (19), in Township One Hundred Twenty (120), of Range Twenty-five (25), lying West of Trunk Highway No. 25 and Southwesterly of the right of way line of the Minneapolis, St. Paul and Sault Ste. Marie Railroad, excepting the South 333 feet thereof,

be and the same is hereby annexed to the Village of Buffalo and shall become a part thererof as effectually as if it had been originally a part thereof.

Section 2. That the annexation of the territory described above shall be determined final upon filing of a copy of the ordinance with the Municipal Commission of the State of Minnesota, the Secretary of State of the State of Minnesota, and the County Auditor of Wright County, Minnesota.
