ORDINANCE ANNEXING CERTAIN LAND TO THE CITY OF MANKATO, PURSUANT TO CHAPTER 686, LAWS OF MINNESOTA, 1959 SESSION.

WHEREAS, The following described tracts of land situated in Blue Earth County, Minnesota, to-wit:

The South Two (2) acres of the East Three (3) acres of the West Eighteen (18) acres of the Southwest Quarter (SW4) of the Southeast Quarter (SE4) of Section Eight (8), Township One Hundred Eight (108), Range Twenty-six (26), according to the government survey.

All of the East Eight (8) acres of the West Thirteen (13) acres of the Northwest Quarter (NW4) of the Southeast Quarter (SE4) North of Agency Road, Section Seventeen (17), Township One Hundred Eight (108), Range Twenty-six (26), according to the government survey,

are completely surrounded by land within the City of Mankato, Blue Earth County, Minnesota, and

WHEREAS, The City Council of Mankato, Minnesota has duly adopted appropriate resolutions stating its intention to annex said land and fixing September 14th, 1959 as the date of hearing thereon, and

WHEREAS, More than ten (10) days prior to said date a copy of said resolution covering each of the above tracts was duly served upon all the owners of each tract of land, as required by law.

WHEREAS, A hearing was duly had as to each of the above described tracts of land on September 14, 1959 at a regular meeting of the City Council of Mankato, Minnesota at which time it was determined that an annexation of said lands to the City of Mankato will be to the best interests of the City of Mankato and the above said tracts of land,

NOW THEREFORE, The City of Mankato, Minnesota does ordain:
