



An Ordinance Annexing Certain Territory to the City of Willmar to be known as LINCOLN ADDITION TO WILLMAR, and Extending the Corporate Limits to Include said Property.

(Adopted pursuant to Laws 1959, Chapter 546, Section 2, Subdivision 7, paragraph 4.)

Section 1. A Petition has been filed with the City Council of the City of Willmar, Minnesota, by all of the owners (in number and amount) of the following described real estate to have such land included within the City of Willmar, Minnesota, which land is described as follows:

The South One Hundred Twenty Five (S 125) feet of the North Three Hundred Fifty (N 350) feet of the East Seventy (E 70) feet of the West One Hundred Eighty Three (W 183) feet, and the South One Hundred Seventy Five (S 175) feet of the North Three Hundred Fifty (N 350) feet of the East One Hundred Fifty (E 150) feet of the West Three Hundred Thirty Three (W 333) feet of the South-west Quarter of the Northeast Quarter (SW 1/4 of NE 1/4) of Section Fourteen (14) in Township One Hundred Nineteen (119) North of Range Thirty Five (35) West, Kandiyohi County, Minnesota, according to the recorded plat thereof.

Section 2. The quantity of land embraced within the foregoing description, and bounded as described, is 71 acres.

Section 3. The City Council hereby determines:

(1) That the annexation will be to the best interest of the City of Willmar, Minnesota, and of the territory affected;

(2) That the territory described herein abuts upon the City and is so conditioned as properly to be subjected to City government.

Section 4. The corporate limits of the City are hereby extended to include the property described in Section 1 hereof, and the same is hereby enacted to and included in the City as effectually as if it had originally been a part thereof.

Section 5. The City Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, the County Auditor of the County of Kandiyohi, and the Secretary of State of the State of Minnesota.

Enactment. The said property, upon the taking effect of this Ordinance, as described in Section 1, having been heretofore platted, shall hereafter be known as "LINCOLN ADDITION TO WILLMAR".

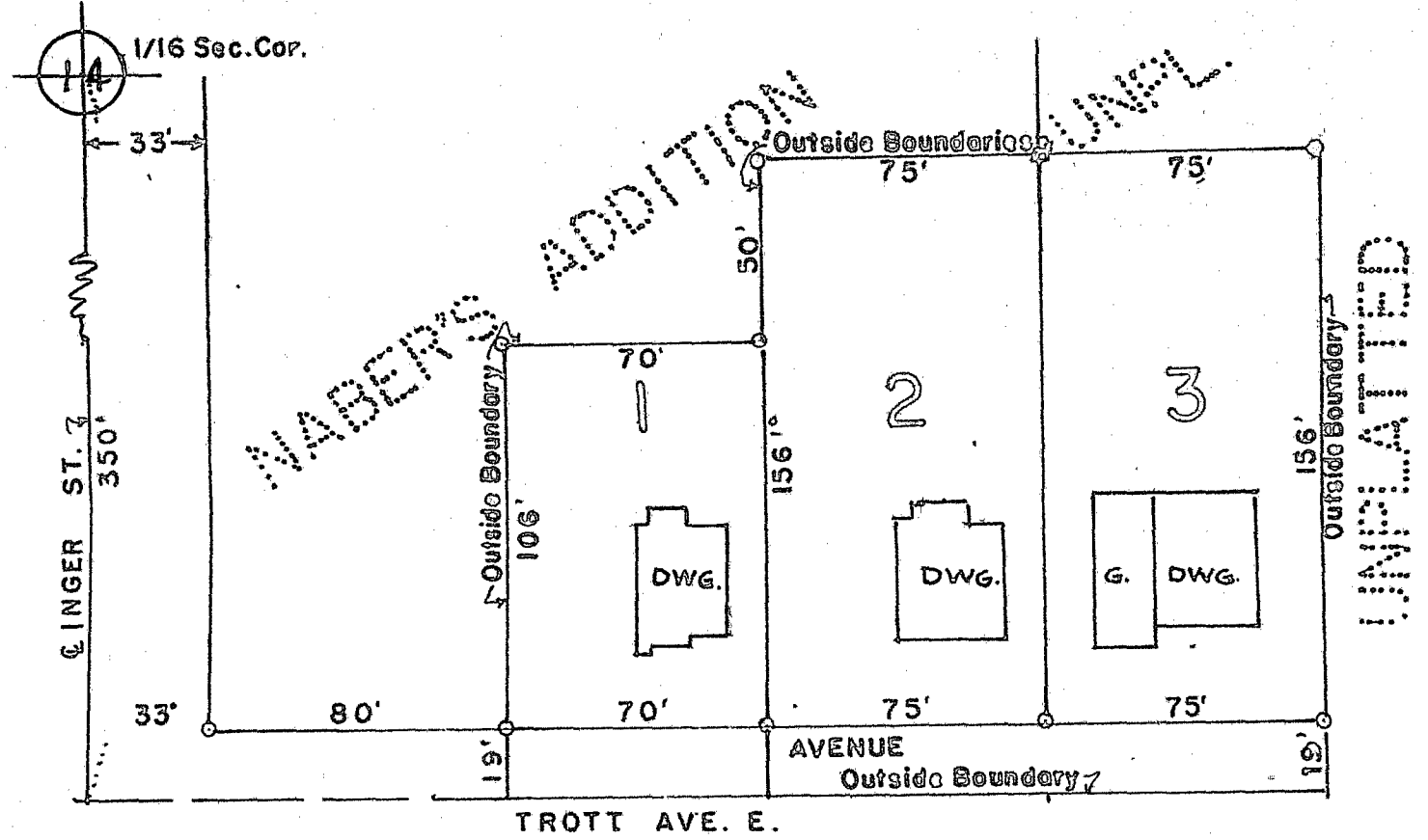
