KNOW ALL MEN BY THESE PRESENTS that I, MILES LORD, Attorney General of the State of Minnesota, by virtue of the authority vested in me by law, do hereby constitute and appoint Elvero J. McMillan, of Duluth, Minnesota, as Special Assistant Attorney General for the State of Minnesota, to bring an action or actions to quiet title or registration proceedings as to the following described lands:

Lot 1 (NE-NE), Section One (1), Township Fifty-eight (58) North, Range Nineteen (19) West, St. Louis County, Minnesota.

The Southeast Quarter of the Northwest Quarter (SE $\frac{1}{4}$ -NW $\frac{1}{4}$ ) and the Southwest Quarter of the Northeast Quarter (SW $\frac{1}{4}$ -NE $\frac{1}{4}$ ), Section One (1), Township Fifty-eight (58) North, Range Nineteen (19) West, St. Louis County, Minnesota.

The Southeast Quarter of the Northwest Quarter (SE $\frac{1}{4}$ -NW $\frac{1}{4}$ ) and the Northeast Quarter of the Southwest Quarter (NE $\frac{1}{4}$ -SW $\frac{1}{4}$ ), Section Thirty-four (34), Township Fifty-nine (59) North, Range Eighteen (18) West, St. Louis County, Minnesota.

Said appointee is to serve at the pleasure of the Attorney General or until this commission shall be revoked or otherwise terminated in accordance with law.

All costs and expenses of such proceedings, including compensation of the Special Assistant Attorney General hereby appointed, shall be paid by the lessee in Faconite Iron Ore Mining Lease Nos. T-5038, T-5037, and T-5024.
