AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF STARBUCK, MINNESOTA, TO INCLUDE CERTAIN PROPERTY OWNED BY THE VILLAGE

The village council of Starbuck ordains:

SECTION 1. It is hereby found and determined that the land and territory described below, now owned by the village and used as an airport, abute on the village, is not included in any other municipality, and that it will be to the best interests of the village of Starbuck and of the said lands and territory that the same be annoxed to the village of Starbuck.

SECTION 2. The corporate limits of the village of Starbuck, County of Pope and State of Minnesota, are hereby extended to include the property and territory in the County of Pope and State of Minnesota, described as follows:
