ORDINANCE NO. 56

AN ORDINANCE EXTENDING THE
CORPORATE LIMITS OF THE VILLAGE
OF STARBUCK, MINNESOTA, TO INCLUDE
CERTAIN PROPERTY OWNED BY THE VILLAGE

The village council of Starbuck ordains:

SECTION 1. It is hereby found and determined that the land and territory described below, now owned by the village and used as an airport, abuts on the village, is not included in any other municipality, and that it will be to the best interests of the village of Starbuck and of the said lands and territory that the same be annexed to the village of Starbuck.

SECTION 2. The corporate limits of the village of Starbuck, County of Pope and State of Minnesota, are hereby extended to include the property and territory in the County of Pope and State of Minnesota, described as follows:

The south 15 acres of the west 30 acres of the southeast quarter of the southeast quarter ($SE\frac{1}{4} SE\frac{1}{4}$) of section twenty-six (26), township one hundred twenty-five (125), range thirty-nine (39), containing 15 acres, more or less, and

That part of the southwest quarter of the southeast quarter ($SW\frac{1}{4} SE\frac{1}{4}$) of section twenty-six (26), township one hundred twenty-five (125), range thirty-nine (39) lying easterly of a line beginning at a point 254 feet west of the southeast corner and running north 24 degrees 4 minutes 30 seconds west to the north line of said southwest quarter of the southeast quarter ($SW\frac{1}{4} SE\frac{1}{4}$), containing 16.7 acres more or less, and

That part of the north half of the northeast quarter ($N\frac{1}{2} NE\frac{1}{4}$) and of the southeast quarter of the northeast quarter ($SE\frac{1}{4} NE\frac{1}{4}$) of section thirty-five (35), township one hundred twenty-five (125), range thirty-nine (39) described as follows: From a point on the north line of said section 35 distant 660 feet west of the east section line run west 912.5 feet along said north line;
thence south 24 degrees 4 minutes 30 seconds east 1460 feet;
thence south 50 degrees 0 minutes east 465 feet;
thence north 65 degrees 55 minutes 30 seconds east 200 feet;
thence north 24 degrees 4 minutes 30 seconds west to the south line of said north half of the northeast quarter ($N\frac{1}{2} NE\frac{1}{4}$);
thence east along said south line to a point 225 feet west of the east section line;
thence north 432.4 feet;
thence west 60 feet;
thence north 102.4 feet;
thence west 111 feet;
thence north 10 degrees 48 minutes west 530.6 feet;
thence south 89 degrees 45 minutes west 165 feet;
thence north 264 feet to the point of beginning;
containing 28 acres more or less; and

SECTION 4. Annexation shall be complete from and after the date when certified copies of this ordinance have been filed as directed in Section 3.
