AN ORDINANCE ADOPTED BY THE VILLAGE OF UPTON,

WHEREAS, a Petition has been filed with the Village Council of the Village of Upton, Chicago County, Minnesota, regarding the annexation of certain lands to said Village of Upton; and,

WHEREAS, the Village Council has determined that said annexation shall be to the best interests of the said Village and of the territory described;

THE VILLAGES COUNCIL OF THE VILLAGE OF UPTON, MINNESOTA; does ordain as follows:

Section 1. That the following described real estate, to-wit:
The northwesterly 600 feet of the Northeast Quarter of the Northwest Quarter of Section 27, Township 29, Range 21, Chicago County, Minnesota, lying westerly of Highway 61, so hereby declared annexed to the said Village of Upton.


Section 2. This Ordinance shall take effect immediately upon its passage and adoption.
