ALLEGEDLY AMENDING ORDINANCE NO. 14  
OF THE VILLAGE OF HYDING

WHEREAS, a Petition has been filed with the Village Council of  
the Village of Hyding, Chicago County, Minnesota, requesting the  
annexation of certain lands to said Village of Hyding, and

WHEREAS, the Village Council has determined that said annexation  
will be to the best interests of the said Village and of the territory

THE VILLAGE COUNCIL OF THE VILLAGE OF HYDING, MINNESOTA, does  
ordain as follows:

Section 1. That the following described real estate, to-wit:

The northerly 433 feet of the Northeast Quarter of the North-  
west Quarter of Section 27, Township 25, Range 21, Chicago County,  
Minnesota, lying easterly of Highway 661, is hereby declared annexed  
to the said Village of Hyding.

Section 2. This Ordinance shall take effect immediately upon  
its passage and adoption.
