

An Ordinance Extending the Corporate Limits of the Village of LaPrairie, to Include Certain Platted and Unplatted Land, Not Exceeding Two Hundred (200) Acres.

Section 1. A petition has been filed with the governing body of the Village of LaPrairie, by a majority of the owners in number of the following described property to have such land included within the Village of LaPrairie.

Lots One (1), Two (2), Three (3), Four (4), Five (5), Six (6) and Seven (7), of HOOLIHAN'S ADDITION TO GRAND RAPIDS, and that part of the Northwest Quarter of the Northwest Quarter (NW 1/4 - NW 1/4) lying South of the Plat of Hoolihan's Addition to Grand Rapids, and the Southwest Quarter of the Northwest Quarter (SW 1/4 - NW 1/4) less the South Three Hundred Feet (300') and less the North Sixty Feet (N 60') of the South Three Hundred Sixty Feet (S 360') of the West Sixty Feet (W 60') and the Southeast Quarter of the Northwest Quarter (SE 1/4 - NW 1/4) and the unplatted part of Government Lot Two (2), lying North of the Great Northern Railway right-of-way, all in Section Twenty-two (22), Township Fifty-five (55) North, Range Twenty-five (25), West of the Fourth Principal Meridian.

Section 2. The quantity of land embraced within the foregoing description, and bounded as described is 125 acres, more or less.

Section 3. A hearing was duly held by the governing body of the Village of LaPrairie, Minnesota, on the proposed annexation after at least thirty (30) days posted notice.

Section 4. The Village Council hereby determines (1) That the annexation will be to the best interest of the Village of LaPrairie, Minnesota, and of the territory affected; (2) That the territory described herein abuts upon the village and is so conditioned as properly to be subjected to village government.

Section 5. Therefore, the Village of LaPrairie hereby ordains and declares that the property hereby described be and the same is hereby annexed to and included in the Village of LaPrairie, Minnesota, as effectively as if it had originally been a part thereof.

Section 6. This ordinance shall be final and shall take effect and be in force from and after filing certified copy thereof with the Minnesota Municipal Commission, the County Auditor and the Secretary of State, and from and after its passage and publication.

Section 1. A petition has been filed with the governing body of the Village of LaPrairie, Minnesota, by a majority of the owners in number of the following described property to have such land included within the Village of LaPrairie.

Lots One (1), Two (2), Three (3), Four (4), Five (5), Six (6) and Seven (7), of HOOVERMAN'S ADDITION TO GRAND RAPIDS, and that part of the Northwest Quarter of the Northwest Quarter (NW  $\frac{1}{4}$ -NW  $\frac{1}{4}$ ) lying South of the Plat of Hooverman's Addition to Grand Rapids, and the Southwest Quarter of the Northwest Quarter (SW  $\frac{1}{4}$ -NW  $\frac{1}{4}$ ) less the South Three Hundred Feet (S 300') and less the North Sixty Feet (N 60') of the South Three Hundred Sixty Feet (S 360') of the West Sixty Feet (W 60') and the Southeast Quarter of the Northwest Quarter (SE  $\frac{1}{4}$ -NW  $\frac{1}{4}$ ) and the unplatted part of Government Lot Two (2), lying North of the Great Northern Railway right-of-way, all in Section Twenty-two (22), Township Fifty-five (55) North, Range Twenty-five (25), West of the Fourth Principal Meridian.
