

ORDINANCE NO. 182

AN ORDINANCE ANNEXING CERTAIN TRACTS OF LAND TO THE CITY OF BRECKENRIDGE, LOCATED IN WILKIN COUNTY, MINNESOTA.

THE COUNCIL OF THE CITY OF BRECKENRIDGE, MINNESOTA, DOES ORDAIN:

1. That pursuant to the provisions of Section 414.03, Subdivision 7, of the Minnesota Statutes, the following described tract of land located in the County of Wilkin, State of Minnesota, which abutts on the City limits of the City of Breckenridge and is owned in its entirety by the City of Breckenridge and is not included in any other municipality, be and it hereby is annexed to the City of Breckenridge located in the County of Wilkin, State of Minnesota:

That part of the Northwest Quarter of the Northwest Quarter (NW $\frac{1}{4}$ NW $\frac{1}{4}$) in Section Four (4) in Township One Hundred Thirty-two (132) North, of Range Forty-seven (47) West of the 5th P.M., described as follows:

Beginning at the Northeast (NE) corner of Government Lot Nine (9) in said Section Four (4); thence running West (W) along the North line of said Government Lot Nine (9) a distance of Eleven Hundred Twenty-two and ninety-seven hundredths feet (1122.97') to the point of curvature of a circular curve whose radius is One Thousand One and ninety-four hundredths feet (1001.94'); thence turning and running North-easterly (NE) along the arc of said circular curve a distance of Two Hundred Seventy-two and fifty-one hundredths feet (272.51') to the point of tangency of said circular curve; thence running North Eighty-nine degrees Fifty-one minutes East (N 89°51' E) a distance of Eight Hundred Fifty-four and eighty-two hundredths feet (854.82') to the point of intersection with the northerly extension of the East line of said Government Lot Nine (9); thence turning and running South (S) along said extension of said East line of said Government Lot Nine (9) a distance of Forty-five and one hundredth feet (45.01') to the point of beginning:

2. A petition having been filed by all of the owners of all of the following described tract of land located in the County of Wilkin and State of Minnesota praying that said tract be annexed to the City of Breckenridge, located in the County of Wilkin, State of Minnesota, which said petition alleges that said tract of land is unplatted, is not included in any municipality, does not exceed Two Hundred acres in area, abutts on the City limits of the City of Breckenridge, is so conditioned as properly to be subject to municipal government and that the annexation will be to the best interests of the municipality and ~~the~~ the said tract affected, and the Council having filed and considered said petition and found the allegations therein to be true, IT IS FURTHER ORDAINED: That pursuant to the provisions of Section 414.03, Subdivision 7, of the Minnesota Statutes, the said following described tract of land, located in the County of Wilkin and State of Minnesota, be and it hereby is annexed to the City of Breckenridge, located in the County of Wilkin, State of Minnesota:

That part of Government Lot One (1) in Section Five (5) in Township One Hundred Thirty-two (132) North, of Range Forty-seven (47) West of the 5th P.M., described as follows:

Beginning at a point on the East line of said Government Lot One (1) a distance of Five Hundred feet (500') South (S) of the Northwest (NW) Corner of Government Lot Nine (9) in Section Four (4) in Township One Hundred Thirty-two (132) North, of Range Forty-seven (47) West of the 5th P.M.; thence running South Seventy-two degrees Fifty-three minutes West (S 72°53' W) to the point of intersection with the Center of the channel of the Red River of the North; thence turning and running South-easterly (SE) along said Center of the channel of said Red

River of the North to the point of intersection with said East line of said Government Lot One (1); thence turning and running North (N) along said East line of said Government Lot One (1) to the point of beginning;

3. That the City Clerk be and he hereby is directed to file a copy of this ordinance with the Commission of Annexation and Incorporation, the County Auditor of Wilkin County, Minnesota, and the Secretary of the State of Minnesota.

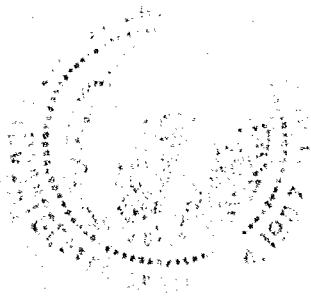
