

Ordinance No. 160

WHEREAS all the owners of the hereinafter described property have petitioned the City Council of the City of Alexandria to annex said property to the City, and

WHEREAS it appears from an examination of said property that the land therein described is completely surrounded by land within the municipal limits of the City of Alexandria; that it is either platted or if unplatted, does not exceed two hundred acres in area, and

WHEREAS The governing body of the City of Alexandria believes that it would be for the best interest of the municipality and of the territory affected that it be so annexed,

NOW THEREFORE THE CITY COUNCIL OF THE CITY OF ALEXANDRIA  
DOES ORDAIN:

Section One. That it is for the best interests of the municipality of the City of Alexandria and of the territory hereinafter described that such territory be annexed to and be made a part of the municipality of the City of Alexandria.

Section Two. That the following described land, to wit:

(a) All that part of the Northwest Quarter of Section Thirty (30), Township One Hundred Twenty Eight (128), Range Thirty Seven (37) - UNPLATTED - which lies west of the East line of Bryant Street in the City of Alexandria extended, and outside of the corporate limits of the City of Alexandria.

(b) All that part of the North Half of Section Thirty (30), Township One Hundred Twenty Eight (128), Range Thirty Seven (37), surrounded by the corporate limits of the City of Alexandria, Minnesota, and bounded on the west by the east line of Fillmore extended in a southerly direction to a point of intersection with the northerly line of the south sixteen acres of the East Twenty Acres of the northwest Quarter of said Section Thirty, and bounded on the south by the said northerly line of the said South Sixteen acres extended easterly to a point of intersection with the west line of the property as annexed to the City of Alexandria, Minnesota, by Ordinance No. 195 dated November 2nd, 1923.

is hereby annexed to and made a part of the municipality of the City of Alexandria, and the corporate limits of the City of Alexandria, Minnesota shall be and hereby are extended to include and encompass the lands and territories above described.

Section Three. All of said lands and territories described by limits, descriptions and boundaries in Section Two above and hereby annexed to and made a part of the City of Alexandria, Minnesota, shall be and do hereby become a part of the following wards of the City of Alexandria:

(a) That part described in Section Two (a) shall be and become a part of the Fifth Ward

(b) That part described in Section Two (b) shall be and become a part of the Fourth Ward.

Section Four. This ordinance shall take effect from and after its passage and publication in accordance with the laws of the State

of Minnesota, the Charter of the City of Alexandria, and upon the filing of a copy of this ordinance with the Municipal Commission of the State of Minnesota, the County Auditor of the County of Douglas, and the Secretary of State of the State of Minnesota.
