

ORDINANCE NO. 83

AN ORDINANCE PROVIDING FOR THE ANNEXATION
OF CERTAIN ADDITIONAL TERRITORIES TO THE
VILLAGE OF NEWPORT, WASHINGTON COUNTY,
MINNESOTA.

THE VILLAGE COUNCIL OF THE VILLAGE OF NEWPORT ORDAINS:

Section 1. That there has been submitted to it a Petition
to annex to the Village of Newport, the following described lands
situated in the County of Washington and State of Minnesota,
to-wit:

The Southwest quarter (SW $\frac{1}{4}$) of the Southwest quarter
(SW $\frac{1}{4}$), Section Nineteen (19), Township Twenty-eight
North (28N), Range Twenty-one West (21W),

and

The Northwest quarter (NW $\frac{1}{4}$) of the Northwest quarter
(NW $\frac{1}{4}$) of Section Thirty (30), Township Twenty-eight
North (28N), Range Twenty-one West (21W),

and

The South one-half of the Northeast quarter (S $\frac{1}{2}$ of NE $\frac{1}{4}$)
of the Northwest quarter (NW $\frac{1}{4}$), and that part of the
Southeast quarter of the Northwest quarter (SE $\frac{1}{4}$ of NW $\frac{1}{4}$),
lying North and East of the County Road No. 4, now
called Cottage Grove Road, (said East tract of land
being formerly described as Lots One to Eleven (Lots
1-11) inclusive, Lots Twenty-three to Forty-four (Lots
23-44) inclusive and Lots Seventy-two to Eighty (Lots
72-80) inclusive, Burlington Acre Lots), all in Section
Thirty (30), Township Twenty-eight North (28N), Range
Twenty-one West (21W),

and

That part of the Southwest Quarter of the Northwest
Quarter (SW $\frac{1}{4}$ of NW $\frac{1}{4}$) of Section Thirty (30, Township
Twenty-eight North (28N), Range Twenty-one West (21W),
Woodbury Township, described as follows, to - wit: The
point of beginning is located on the shoreline of Lake
Ria, which point is 364.3 feet West of the Northeast
corner of the Southwest Quarter of the Northwest Quarter
(SW $\frac{1}{4}$ of NW $\frac{1}{4}$) of Section Thirty (30), Township Twenty-
eight North (28N), Range Twenty-one West (21W), Woodbury
Township, Washington County, State of Minnesota; thence
East along the North line of the Southwest Quarter of
the Northwest Quarter (SW $\frac{1}{4}$ of NW $\frac{1}{4}$) for 364.3 feet to
the Northeast corner of said quarter section; thence

South along the East line of said quarter section for 685.8 feet to the North line of the County Highway; thence Northwest along said North line of County Highway for 273.46 feet; thence in a straight line to the Southwest corner of Lot 21 of Burlington Acre Lots now vacated as now on file and of record in the office of the Register of Deeds in and for County of Washington and State of Minnesota; thence North along the West line of said vacated Lot 21 for 399.4 feet to the Northwest corner of said Lot 21 (which is the same as the Southwest corner of Lot 14 of said Burlington Acre Lots); thence West along the South line of said Lot 14 for 314.6 feet, more or less, to the shoreline of Lake Minn; thence Northeast along the shore line of Lake Min to the point of beginning, containing six (6) acres, more or less, being formerly known as Lots 12, 13, 14, 21, 22, of Burlington Acre Lots Addition, now vacated and that portion of vacated streets and alleys adjoining said lots which attach to and become a part of said lots by reason of the vacation thereof.

Section 2. That it is hereby found, determined and declared:

A) That all of the owners of the lands described in Section 1 joined in said petition.

B) That all of the allegations contained in said Petition are true and that said Petition is approved.

C) That annexation of the territory described in Section 1 will be to the best interest of the Village of Newport and of the territory described in Section 1.

D) That the territory abuts the Village and is not included in any other municipality and is so conditioned as to properly be subjected to Village government.

E) That the area included in Section 1 described above contains 143 acres and has a population of 16.

Section 3. That it is hereby declared that the lands described in Section 1 of this ordinance are annexed to the Village of Newport, pursuant to law.

Section 4. That a copy of this Ordinance shall be filed with the Washington County Auditor, Secretary of the State of Minnesota, and the Minnesota Municipal Commission and shall be published according to law.

Section 5. This ordinance shall take effect and be enforced from and after its publication, according to law, and filed as provided in Section 4 herein.
