

ORDINANCE NO. 162

AN ORDINANCE TO EXTEND THE BOUNDARIES OF THE VILLAGE OF SAUK RAPIDS
AND INCORPORATE ADDITIONAL TERRITORY THEREIN

THE VILLAGE COUNCIL OF THE VILLAGE OF SAUK RAPIDS DOES ORDAIN:

Section 15:13. Village Boundaries Extended. Pursuant to a petition
duly signed by all of the owners of the land in Benton County described as
follows:


A tract of land being all that part of Government Lot Two (2)
and the North one-half of Government Lot Three (3) in Section
Fifteen (15), Township Thirty-six (36) North, Range Thirty-one
(31) West, West of the Fourth Principal Meridian, lying between
the Easterly shoreline of the Mississippi River and the Westerly
right of way line of the Northern Pacific Railroad. Said tract
containing 16.85 acres (more or less) and being platted as
Fischer's Acre Tracts,

The territorial limits of the Village are hereby extended to include such
land within its limits, which shall hereafter be governed as other terri-
tory of the village is governed. Said land shall be zoned commercial.

Section 15:14. Copies to be filed. The Village Clerk shall forward
a certificate of this ordinance to the Secretary of State and to the County
Auditor for Benton County, Minnesota.

Section 15:15. Effect. Such land shall be annexed upon the filing of
the certified copies hereof with the Secretary of State and the County Auditor.

Passed by the Council this 9th day of February, 1960.






