


**CERTIFICATE**

Extending the corporate limits of the City of Austin to the East.

WHEREAS the City of Austin, Minnesota, a municipal corporation, is the sole owner of all of the premises hereafter described, and,

WHEREAS said premises adjoin the City of Austin and are subject to incorporation within the corporate limits of Austin, Minnesota by Ordinance of the governing body of the City of Austin, and

WHEREAS it is to the best interest of the City of Austin and the premises hereinafter described that said premises be annexed to the City of Austin and said premises proposed to be annexed are well fitted and adapted to be under municipal government and control and municipal use, and

WHEREAS there are no other interested parties who have any interest of any nature in the premises hereinafter described other than the City of Austin, Minnesota and said City of Austin owns said premises in fee simple, free from encumbrances.

NOW THEREFORE THE COMMON COUNCIL OF THE CITY OF AUSTIN DO ORDAIN:

SECTION 1.

That the land hereinafter described be added to and incorporated within the corporate limits of the City of Austin, Minnesota and said Common Council does hereby declare said premises hereinafter described to be incorporated within and to be a part of the City of Austin, Minnesota. The premises are described as follows:

All of the N. E.  $\frac{1}{4}$  of Section 1, T.-102-N., R.-18-W. with the exception of the below described tract.

Beginning at a point fifty-eight feet south of the N.W. corner of the N.E.  $\frac{1}{4}$  on the center line of Section 1, T.-102-N., R.-18-W.; thence south along the center line of Section 1, a distance of 832.3 feet to the south property line of 6th Avenue N.E. (formerly Clark Street) thence east along the south property line of 6th Avenue N.E. (formerly Clark Street) extended, a distance of 260 feet; thence north, parallel with the center line of Section 1, a distance of 832.3 feet to a point 58 feet south of the north line of the said  $\frac{1}{4}$  section; thence west 260 feet to the point of beginning.

The following described tract shall also be included in the annexation:

Beginning at a point 1171.12 feet east of the center of Section 1, T.-102-N., R.-18-W. on the  $\frac{1}{4}$  Section line; thence east on the  $\frac{1}{4}$  Section a distance of 1171.12 feet to the N.E. corner of the S.E.  $\frac{1}{4}$  of Section 1; thence south along the section line a distance of 3461 feet to a point which is 759 feet south of the N.E. corner of the N.E.  $\frac{1}{4}$  of Section 12, T.-102-N., R.-18-W.; thence west on a line parallel to the north line of said  $\frac{1}{4}$  Section a distance of 660 feet; thence south on a line parallel to the east line of said  $\frac{1}{4}$  section, distance of 561 feet; thence west on a line parallel to the north line of said  $\frac{1}{4}$  section a distance of 440 feet; thence north on a line parallel to the east line of said  $\frac{1}{4}$  section a distance of 1320 feet to the south line of the S.E.  $\frac{1}{4}$  of Section 1, T.-102-N., R.-18-W.

thence west along the above described section line a distance of 221.22 feet; thence north on a line parallel to east line of the S.E.  $\frac{1}{4}$  of Section 1 a distance of 1482.65 feet; thence northwesterly 1168.85 feet to the point of beginning, all in Hower County, Minnesota.

SECTION 2.

The above described land extending the corporate limits of the City of Austin, Minnesota, shall be added to the end of 2300.69, Austin Compilation in the regular chronological order.

SECTION 3.

Said annexation shall not be final until copies of this Ordinance have been filed with the Municipal Commission of the State of Minnesota, the Secretary of State and the County Auditor of Hower County, Minnesota.
