ORDINANCE NO. 34

Entitled an ordinance extending the boundaries of the Village of Waite Park, Stearns County, Minnesota, so as to include within said Village certain unplatted real estate not exceeding two hundred acres of land abutting upon said Village.

The Village Council of the Village of Waite Park in the County of Stearns, Minnesota, do hereby ordain as follows:

Section 1. Whereas, The Great Northern Railway Company a corporation duly authorized and existing under pursuant to and by virtue of the laws of the State of Minnesota, who is the owner of the real estate hereinafter described, which said real estate is unplatted land and abuts upon said village and the acres of said land is less than two hundred acres, has duly petitioned the said Village Council of said Village of Waite Park to have said real estate annexed to said village and that the boundaries of said village extended by proper ordinance so as to include the said real estate within said village, and whereas the said Village Council has duly considered said matter. Now therefore

Section 2. The boundaries of said Village of Waite Park are hereby extended so as to include within said boundaries of said village the real estate hereinafter described, which is unplatted land and which is situate within the County of Stearns and State of Minnesota and the area of which said land is less than two hundred acres and which said land abutts upon the said Village of Waite Park and said real estate is described as follows,to-wit:

All that part of the south half $(S_{\overline{2}}^1)$ of section eight (8) and the southwest quarter $(SW_{\overline{4}}^1)$ of section nine (9), township one hundred twenty-four (124), north, range twenty-eight (28) west, lying south of said railway company's Barnesville line of railway, and north and west of said railway company's Willmar Branch branch line of railway.

That the south line of said sections is the medial line of what was originally Rockville Road, (later Rockville Avenue, now 3rd St.) in the Village of Waite Park, between the west line of Ashwood Avenue (now 13th Avenue), in said village, and the northwesterly boundary of the right of way of said railway company's Willmar Branch line of railway.

That the north thirty-three (33) feet of said part of Third Street extends over and upon the said described lands owned by said railway company, subject to an eastment therein for highway purposes.

Section 4. That the boundaries of said village are extended as as to include said real estate as aforesaid within the said village with the understanding that it does not entail any liability on or against/real estate for assessments for benefits on account of public improvements in said village.

Section 5. This Ordinance shall take effect and be in force from and after its passage and publication.
