AN ORDINARCE PROVEDING FOR THE AMERIMENT OF ORDINARCE NO. US ENTITLED "AN ORDINARCE PROVIDING FOR THE AMERICATION OF CERTALS ADDITIONAL TERRITORIES TO THE VILLIGE OF MEMPORT, WASHINGTON COUNTY, MINNESOTA" FOR THE PURPOSE OF CORRECTING A LEGIL DESCRIPTION THEREIN.

THE VILLAGE COUNCIL OF THE VILLAGE OF HARDET ORD ING:

That Section 1 of Ordinance No. 83 is hereby repealed and in lieu thereof, the following language shall be inserted therein:

Section 1. That there has been submitted to it a Petition to amen to the Village of Newport, the Following described lands situated in the County of Washington and State of Minnesota, to-wit:

The Southwest quarter (SW) of the Southwest quarter (SW). Section Minetoen (19). Township Twenty-eight North (28N). Range Twenty-one West (21N).

and

The Northwest quarter (NWW) of the Northwest quarter (NWW) of Section Thirty (30). Township Twenty-eight North (28N), Range Twenty-one West (21N),

and

The South one-helf of the Northeast quarter (St of NEW) of the Northwest quarter (NWW), and that part of the Southeast quarter of the Northwest quarter (SEW of NWW), lying North and East of the County Road No. 4, now called Cottage Grove Road, (said East tract of land being formerly described as Lots One to Eleven (Lots L-11) inclusive, Lots Twenty-three to Forty-four (Lots 23-44) inclusive and Lots Seventy-two to Eighty (Lots 72-80) inclusive, Burlington Acre Lots), all in Section Thirty (30), Township Twenty-eight North (28N), Range Twenty-one West (21W).

soint of beginning is located on the shoroline of Lake Min. which point is 364.3 feet wost of the Mortheast corner of the Southwest Quarter of the Morthwest Quarter (Sit of Mit) of Section Thirty (30), Township Twentyoight North (201), Range Twenty-one West (211), Woodbury Township, Washington County, State of Minnesota; thence East along the North line of the Southwest Quarter of the Northwest Quarter (SH, of NV.) for 364.3 feet to the Northeast corner of said quarter section; thence South along the East line of said quarter section for 867.4 feet to the North Line of the County Highway: thence Northwesterly along said North line of County Highway for 273.45 feet; thence in a straight line to the Southwest corner of Lot 21 of Burlington Acre Lots now vacated as now on file and of record in the office of the Register of Deeds in and for County of Washington and State of Minnesota; thence North along the West line of said vacated Lot 21 for 299.4 feet to the Northwest corner of said Lot 21 (which is the same as the Southeast corner of Lot 14 of said Burlington Aure Lots); thence West along the South line of said Lot 14 for 314.6 feet, more or less, to the shoreline of Lake Ria; thence Northeasterly along the shoreline of Lake Ria to the point of beginning, containing six (6) acres, more or less, being formerly known as Lots 12, 13, 14, 21, 22, 45 of Burlington Acre Lote Addition, now vacated and that portion of vacated streets and alleys adjoining said lots which attach to and become a part of said lots by reason of the vacation thereof.

Section 2. That it is hereby found, dotermined and declared that said amendment does not change the character, area or determinations found in Section 2 of Ordinance No. 83 and that said territory abute the Village and is not included in any other municipality and is so conditioned as to properly be subjected to Village government and is hereby declared annexed to the Village of Newport.

Section 3. That a copy of this Ordinance shall be filed with the Washington County Auditor, Secretary of State of Minnesota, and the Minnesota Municipal Commission and shall be published according to law.

Section 4. This ordinance shall take offect and be onforced from and after its publication, according to law, and filed as provided in Section 4 herein.
