AMENDMENTS

to the

CHARTER OF THE CITY OF BRECKENRIDGE.

Framed, proposed and submitted pursuant to Section 36, of Article 4, of the Constitution of the State of Minnesota, and Chapter 9, of the Revised Laws of the State of Minnesota for the year 1905, and the Acts Amendatory thereof.

The Board of Freeholders, constituting the Charter Commission of the City of Breckenridge, Minnesota, do hereby frame, propose and submit the following amendments to the Charter of the City of Breckenridge.

Proposed Amendment No. I.

It is hereby proposed and submitted by the Charter Commission of the City of Breckenridge, Minnesota, that Section 98 of Chapter V, of the City Charter of said City, be and the same is hereby amended by inserting therein immediately following sub-division 3, an additional sub-division to be numbered sub-division 4, and to read as follows:

"4. For the purpose of raising, not to exceed Twenty-five Thousand Dollars to aid in and defray the expense of constructing a building to be used as and for a City Hall and jail; <u>provided</u>, <u>however</u>, that when bonds shall have once been issued pursuant hereto, whether for the full amount hereby authorized or for a lesser amount, no bonds shall again be issued under this sub-division".

Proposed Amendment No. 2.

It is hereby proposed and submitted by the Charter Commission of the City of Breckenridge, Minnesota, that Division I, of Part II, of Chapter XII, of the City Charter of said City, be and the same is hereby amended by adding thereto at the end of Section 195, the following:

"GENERAL SYSTEM OF SEWERS AND SEWER DISTRICTS.

1. The Council may at any time establish a general sewer system, and may classify sewers as general, district, joint-district and lateral, General sewers shall be the designation of such large sewers as shall be common to the entire City or used as outlets for district or joint district sewers, and shall not include those which may or shall be constructed for the immediate draining of any particular district. District sewers shall be the designation of all main sewers laid for the immediate draining of a particular sewer district. Joint
