ORDINANCE NO. 292

AN ORDINANCE ANNEXING PROPERTY TO THE CITY OF WHITE BEAR LAKE, MINNESOTA

WHEREAS, the majority of the property owners of the real estate hereinafter described, have petitioned the City Council of the City of White Bear Lake, Minnesota, to have the following described real estate annexed to the City of White Bear Lake, Minnesota; and,

WHEREAS, the real estate hereinafter described is abutting to the City of White Bear Lake, is not included in any other municipality and is so conditioned as properly to be subjected to municipal government; and,

WHEREAS, the City Council deems it advisable and in the public interest that said property be so amnexed,

NOW, THEREFORE, the City Council of the City of White Bear Lake, Minnesota, does ordain as follows:

Section 1. That the following described real estate situated in Ramsey County, Minnesota:

Lots twelve (12) and thirteen (13), Block one (1), Bronson Addition,

be and the same is hereby annexed to the City of White Bear Lake, Minnesota, and the said property is hereby declared to be an addition to said City.

Section 2. Upon the effective date of this Ordinance such property shall become a part of said City as effectively and as if it had been originally a part thereof.

Section 3. This Ordinance shall take effect and be in force from and after its passage and publication, and the City Manager of the City of White Bear Lake, Minnesota, is directed to cause a certified copy of this Ordinance to be recorded and filed in the office of the County Auditor, Ramsey County, Minnesota, the Secretary of State and the Commission created under Chapter 686, 1959 Laws of Minnesota.
