

ORDINANCE NO. 294

AN ORDINANCE ANNEXING PROPERTY TO THE  
CITY OF WHITE BEAR LAKE, MINNESOTA

WHEREAS, the majority of the property owners of the real estate hereinafter described, have petitioned the City Council of the City of White Bear Lake, Minnesota, to have the following described real estate annexed to the City of White Bear Lake, Minnesota; and,

WHEREAS, the real estate hereinafter described is abutting to the City of White Bear Lake, is not included in any other municipality and is so conditioned as property to be subjected to municipal government, and,

WHEREAS, the City Council deems it advisable and in the public interest that said property be so annexed,

NOW, THEREFORE, the City Council of the City of White Bear Lake, Minnesota, does ordain as follows:

Section 1. That the following described real estate situated in Ramsey County, Minnesota:

The north one-half (N 1/2) of the Northwest Quarter (NW 1/4) of the Northeast Quarter (NE 1/4) of Section Fourteen (14), Township Thirty (30), Range Twenty-two (22), except the West 333 feet thereof; and except that part of the North one-half (N 1/2) of the Northwest Quarter (NW 1/4) of the Northeast Quarter (NE 1/4) of Section 14, Township 30, Range 22, described as follows: Beginning at a point on the East line of the said North one-half (N 1/2) of said Quarter quarter section distant 464.31 feet South of the Northeast corner of the North one-half of said Quarter Section; thence South along said East line 75 feet; thence West 189.15 feet to a point which is 539.23 feet South of the North line of the North 1/2 of said Quarter Section; thence North 75 feet; thence East 189.19 feet to the place of beginning, excepting part taken for Division Street, as conveyed to Beatrice N. Baker by deed dated June 5, 1947, recorded in Book 1311 Deeds, page 35, in the office of the Register of Deeds for Ramsey County, Minnesota; according to the Government survey thereof, subject to the rights of the public in Division Avenue except any part now within the City of White Bear Lake.

be and the same is hereby annexed to the City of White Bear Lake, Minnesota, and the said property is hereby declared to be an addition to said City.

Section 2. Upon the effective date of this Ordinance such property shall become a part of said City as effectively and as if it had been originally a part thereof.

Section 3. This Ordinance shall take effect and be in force from and after its passage and publication, and the City Manager of the City of White Bear Lake, Minnesota, is directed to cause a certified copy of this Ordinance to be recorded and filed in the office of the County Auditor, Ramsey County, Minnesota, the Secretary of State and the Commission created under Chapter 686, 1959 Laws of Minnesota.






