ORDINANCE NO. 300

AN ORDINANCE ANNEXING PROPERTY TO THE CITY OF WHITE BEAR LAKE, MINNESOTA

WHEREAS, the majority of the property owners of the real estate hereinafter described, have petitioned the City Council of the City of White Bear Lake, Minnesota, to have the following described real estate annexed to the City of White Bear Lake, Minnesota; and,

WHEREAS, the real estate hereinafter described is abutting to the City of White Bear Lake, is not included in any other municipality and is so conditioned as property to be subjected to municipal government; and,

WHEREAS, the City Council deems it advisable and in the public interest that said property be so annexed,

NOW, THEREFORE, the City Council of the City of White Bear Lake, Minnesota, does ordain as follows;

Section 1. That the following described real estate situated in Ramsey County, Minnesota:

Subject to Bellaire Ave., the Northwest quarter (NW $\frac{1}{2}$) of Northwest quarter (NW $\frac{1}{2}$) of Southeast quarter (SE $\frac{1}{2}$) of Section twenty-five (25), Township thirty North (30 N) Range twenty-two (22) West, Ramsey County, Minnesota, and the South 167 feet of Southwest quarter (SW $\frac{1}{2}$) of Southwest quarter (SW $\frac{1}{2}$) of Northeast quarter (NE $\frac{1}{2}$) of said Section twenty-five (25)

The South 500 feet of the Southwest quarter (SW $\frac{1}{2}$) of the Southwest quarter (SW $\frac{1}{2}$) of the Northeast quarter (NE $\frac{1}{2}$) of Section twenty-five (25), Township thirty (30), Range twenty-two (22), except the South 167 feet thereof, subject to roads
