ORDINANCE NO. 314

AN ORDINANCE AMENDING PROPERTY TO THE CITY
OF WHITE BEAR LAKE, MINNESOTA

WHEREAS, the majority of the property owners of the real estate herein-
after described, have petitioned the City Council of the City of White Bear
Lake, Minnesota, to have the following described real estate annexed to the
City of White Bear Lake, Minnesota; and

WHEREAS, the City Council deems it advisable and in the public interest
that said property be so annexed.

NOW, THEREFORE, the City Council of the City of White Bear Lake, Minn-
esota, does ordain as follows:

Section 1. That the following described real estate situated in Ramsey
County, Minnesota:

- (1.) Lots Eleven (11) through Fourteen (14), Block Thirteen,
Eastwood Manor; Lots Sixteen (16) through Twenty-nine
(29), Block Fourteen (14), Eastwood Manor; all of Block
Fifteen (15), Eastwood Manor; Lots One (1) through
Thirteen (13), Block Sixteen (16), Eastwood Manor; and
the easterly one-half of the south 150 feet of the north
650 feet of the east 320.79 feet of the Southeast Quarter
of the Northeast Quarter of Section 29, Township 30, Range
22, according to the Government Survey thereof, except
"East County Line Road".
- (2.) Lot Nine (9), Block Three (3), Thero's Lakeside No. 2.
- (3.) Lots One (1) through Seven (7), Block Three (3), Brook-
dale Park, according to the plat thereof,

be and the same is hereby annexed to the City of White Bear Lake, Minnesota,
and the said property is hereby declared to be an addition to said City.

Section 2. Upon the effective date of this Ordinance such property shall
become a part of said City as effectively and as if it had been originally a
part thereof.

Section 3. This Ordinance shall take effect and be in force from and
after its passage and publication, and the City Manager of the City of White
Bear Lake, Minnesota, is directed to cause a certified copy of this Ordinance
to be recorded and filed in the office of the County Auditor, Ramsey County,
Minnesota, the office of the Secretary of State for the State of Minnesota,
and the Minnesota Municipality Commission.
