

ORDINANCE NO. 78

AN ORDINANCE ANNEXING CERTAIN REAL
ESTATE TO THE VILLAGE OF MORGAN

WHEREAS a petition has been filed by William S. Kamholz and Marian L. Kamholz with this Council requesting the annexation of certain real estate hereinafter described to the Village of Morgan, and

WHEREAS this Council has found, and hereby finds, determines and declares that said real estate abuts on the Village of Morgan; that the same is not included in any other municipality; that the same is so conditioned as properly to be subject to municipal government, and that the same is unplatted and does not exceed two hundred (200) acres in area, and

WHEREAS this Council has found and hereby finds, determines and declares that the said petition has been signed by all the owners of said property, and that the annexation thereof to the Village of Morgan will be to the best interests of the municipality and of the territory affected,

NOW THEREFORE the Village of Morgan does ordain:

1. That the following-described real estate lying and being in Redwood County, Minnesota, to wit:

Beginning at the West Quarter ($W\frac{1}{4}$) corner of Section 15, Township 111 North, Range 34 West, and running thence North 420 feet, thence East 695.27 feet, thence South 21 feet; thence West 60 feet, thence South 296.7 feet, thence South 43 degrees 58 minutes West 141 feet, thence due West 569.17 feet to the place of beginning, and containing 5.97 acres

be and is hereby declared to be annexed, and is hereby annexed to the Village of Morgan.

2. That the real estate hereinabove described be and is hereby declared to be and made subject to its proportionate share of the debts and obligations of the Village of Morgan
