

ORDINANCE NO. 1512

Providing for the Annexation of Property

Introduced by Councilman Carlton H. McMillan

WHEREAS, petitions, signed by Clifford P. Pickett, Rosa Pickett, husband and wife, Jens Kirk, Esther Kirk, husband and wife, Roy P. Gosper, Carol J. Gosper, husband and wife, Leonard Sipple, Betty H. Sipple, husband and wife, dated February 17, 1960 and February 9, 1960 has been filed with the City Council requesting the annexation of certain property to the City of Albert Lea, said petition containing the names of all owners of said property, and,

WHEREAS, the City Council of the City of Albert Lea does determine that it will be to the best interests of the City of Albert Lea and said property to annex the same to the City, pursuant to laws 1957, Chapter 686 Sec. 3, Sub 7, said Property abutting upon the City of Albert Lea and containing 0.3 acres.

THE CITY OF ALBERT LEA DOES ORDAIN:

Sec. 1. The following described property viz:

Commencing at the N.E. corner of the 1/4 of the 1/4 of Sec. 5-102-21 thence east on the quarter line 716.7 ft; thence S 42° 13' east a distance of 271.0'; thence east a distance of 537.2 ft; thence north 212.5 ft; thence east 130 ft; thence north a distance of 437.3 ft to the point of beginning being a part of the 1/4 1/4 Sec. 5-102-21 also  
The West 1/4 of the 1/4 of the 1/4 of the 1/4 of the 1/4 Sec. 5-102-21 less the south 5 ft thereof.

as included in the above mentioned petitions, is hereby declared to be an addition to the City of Albert Lea as effectually as if it had been originally a part thereof, said annexation to be deemed final upon filing a copy of this ordinance with the Commission, the County Auditor and the Secretary of State.


