Ordinance for the acquisition of property

enacted by the City Council of the City of Albert Lea, Minnesota

... petition, signed by the Chicago & North Western Railway, dated February 23, 1960 has been filed with the City Council ... the acquisition of certain property to the City of Albert Lea, said petition reciting the name of owners of said property, and,

... the City Council of the City of Albert Lea has determined that it will be to the best interests of the City of Albert Lea and said property to annex the same to the City, pursuant to laws 1957, Chapter 476 Sec. 3 Sub. 7, said property abutting upon the City of Albert Lea and containing .96 acres.

THE CITY OF ALBERT LEA, MINNESOTA

Sec. 1. The following described property viz:

Beginning at a point on the east-west center section line of section 9, Township 132, Range 21, which point is 15 feet east of the centerline of Shirley Avenue as platted in the City of Albert Lea, Minnesota; thence south 150.35 feet to a point of intersection with the north line of the Chicago, Rock Island and Pacific Railroad Company right-of-way; thence northeasterly along said railroad right-of-way to a point of intersection with the east-west centerline of said section 9; thence west along the said east-west centerline of said section 9 to the point of beginning, being a triangular tract of land.

as included in the above mentioned petition, is hereby declared to be an addition to the City of Albert Lea as effectually as if it had been originally a part thereof, said annexation to be deemed final upon filing a copy of this ordinance with the Commissioner, the County auditor and the Secretary of State.

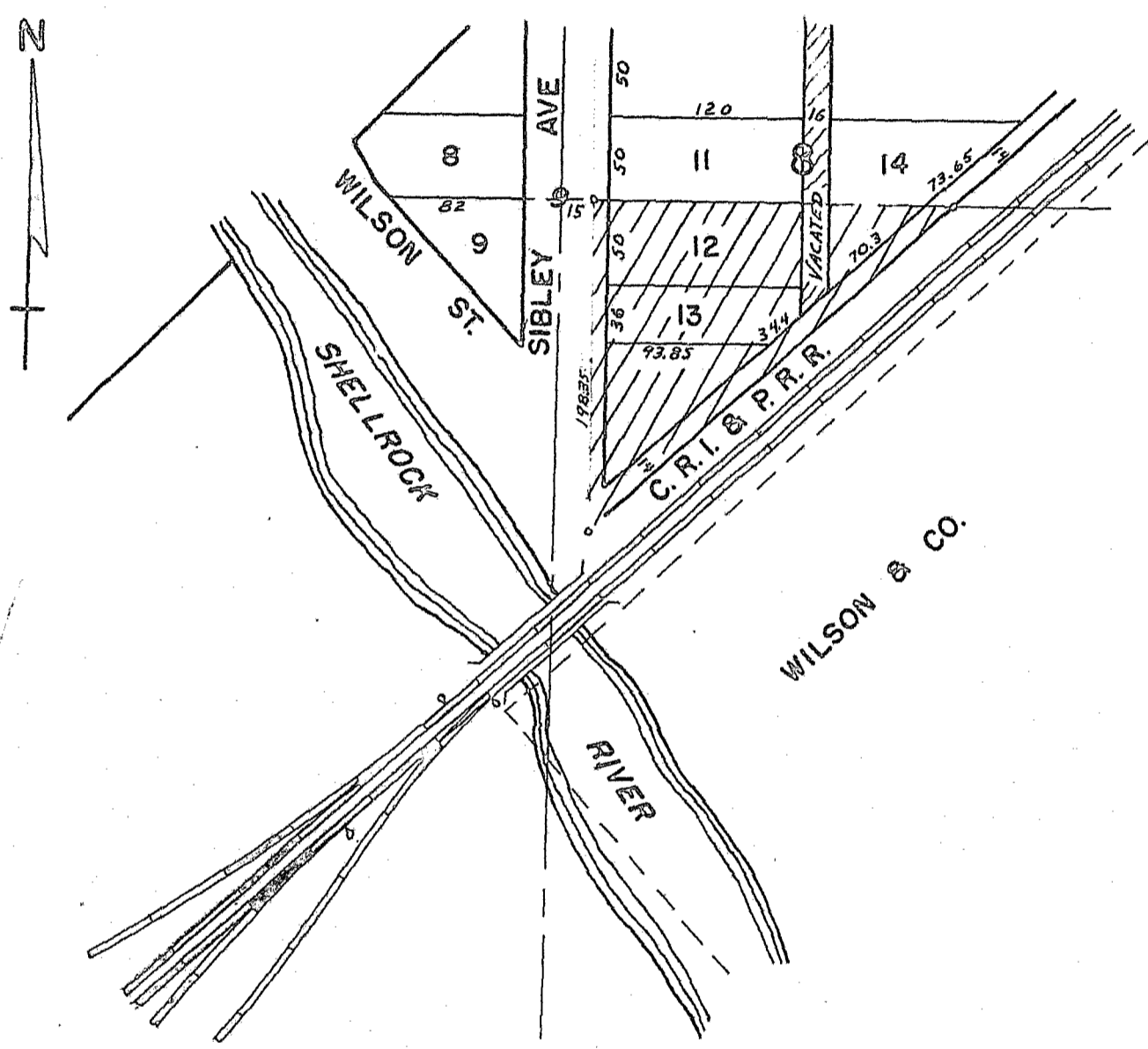
