## CHAPTER NO. 280

AN ORDINANCE TO ANNEX certain tracts of land to the City of Montevideo and declaring said tracts to be an addition to and a part of the City of Montevideo.

MHEREAS, a petition has been filed with the City Council of the City of Montevideo by the owners in fee of the following described tracts of land lying and being in the County of Chippeva, State of Minnesota, to wit:

A part of Lot Three (3) in the Subdivision of the Nest Half of the Northeast Quarter ( $W_{\rm F}^1$  of NE4) of Section Seven (7), in Tourship One Hundred Seventeen (117) North, Range Forty (40) West of the Fifth Principal Meridian described as follows, to wit: Beginning at the southwest corner of said Lot Three (3) and running thence East on the South line of said Lot Two hundred fifty (250) feet; thence north parallel with the west line of said Lot one hundred twentyseven (127) feet; thence west parallel with the south line of said Lot two hundred fifty (250) feet; thence south along the yest line of said lot one hundred twenty-seven (127) feet to the place of beginning.

praying that said tracts be annexed to and made a part of the City of Montevideo, and

WHEREAS, it appears that said tracts of land abut upon the incorporated City of Montevideo, that said petitioners are the sole owners in fee thereof, that said tracts of land are suitable for residential purposes and are so located as to be properly subject to annexation to the City of Montevideo and are suitable and adaptable to municipal purposes and municipal regulations, control and government.

NOW THEREFORE, the City of Montevideo does ordain as follows:

Section 1. That the certain tracts of land lying and being in the County of Chippewa, State of Minnesota, described as follows, to wit:

A part of Lot Three (3) in the Subdivision of the West Half of the Northeast Quarter (N2 of NEA) of Section Seven (7), in Tourship One Hundred Seventeen (117) North, Range Forty (40) West of the Fifth Principal Meridian described as follows, to wit: Beginning at the southwest corner of said Lot Three (3) and running thence East on the South line of said Lot two hundred fifty (250) Teet; thende north parallel with the west line of said Lot one hundred twontyseven (127) feet; thence west parallel with the south line of said Lot two hundred fifty (250) feet; thence south along the vest line of said Lot one hundred twenty seven (127) feet to the place of beginning.

be and the same is hereby declared to be annexed to the City of Montevideo and that said tracts of land are hereby declared to be an addition to the City of Montevideo and are hereby made a part of said City of Montevideo and of the residence district thereof as defined and described by the ordinances of said City.

#145470.0 Section 2. This Ordinance shall take effect and be in force from and after its publication according to the provisions of the City Charter.
