PAUL, MINNESOTA, AS SPECIAL ASSISTANT ATTORNEY GENERAL IN THE DEPARTMENT OF TAXATION FOR THE PERIOD COMMENCING MAY 5, 1960, AND TO SERVE AT THE PLEASURE OF THE ATTORNEY GENERAL, OR UNTIL THIS COMMISSION SHALL BE REVOKED OR OTHERWISE TERMINATED IN ACCORDANCE WITH LAW; AND I HEREBY FIX THE COMPENSATION OF SAID JEROME J. SICORA AS SUCH SPECIAL ASSISTANT ATTORNEY GENERAL AT THE SUM OF TEN THOUSAND TWO HUNDRED AND FIFTY DOLLARS (\$10,250.00) PER YEAR, TO BE PAID FROM THE APPROPRIATION MADE FOR THE DEPARTMENT OF TAXATION.


