

CERTIFICATE

AMENDMENT TO THE CHARTER OF THE City of Austin, in  
Mower County, Minnesota.

THIS IS TO CERTIFY that I, the undersigned, am the  
chief magistrate to the City of Austin, in Mower County, Min-  
nesota; that I am the Mayor of said city; that the seal  
hereto attached is the corporate seal of said city; That  
an election was duly held <sup>in said city,</sup> on the 15th day of June, 1915:  
That notice thereof was duly and legally given; that the election  
was duly and legally held: That the ~~xxxxxx~~ ballots were duly  
and legally cast, voted, counted, canvassed and returned: That  
the results of said election were duly and legally returned,  
published and declared: That the following amendment to the  
charter of said city was duly and legally proposed, submitted  
and adopted by three-fifths of those lawfully voting at said  
election, and that three-fifths of those lawfully voting at  
said election did duly and legally declare in favor of said  
amendment so proposed and hereinafter set forth in full; and  
that three-fifths of the qualified voters of said city, voting  
at said election, did ratify the said following amendment, ~~xxx/xxx~~  
as-wit:

Chapter 12 of the Charter of the City of Austin, hereby amended by adding thereto a new section to be known and designated as Section 10 as follows:

Section 10. The Common Council, upon application made to it, by Resolution passed by the Park Board shall hereinafter be hereby authorized to purchase additional land or rights in land, contiguous to the Horace Austin State Park or other parks either within or without the corporate limits of said City. Such purchase or purchases may be paid for out of the Park funds with the consent of the Park Board, or out of the General funds of the City not otherwise appropriated, or out of the funds that may be raised as herein after provided.


The Park Board is hereby authorized to expend any money under its control, not otherwise appropriated, for improving, maintaining, beautifying and caring for the Public Parks of the City including the Horace Austin State Park; also any land in which the City has an easement, within or without the corporate limits of the City, but contiguous to any such parks; and the Common Council may transfer moneys not otherwise appropriated to the Park Board from the General fund, or from moneys raised as herein provided.

For the purpose of furnishing additional funds for Park purposes, as hereinbefore provided in this section, the Common Council may from time to time issue the bonds of said City in a total sum not exceeding \$10,000, and not exceeding the legal limits of bond issue, with interest at not exceeding 6% per annum due in from one to thirty years as authorized by resolution of said Common Council. Such bonds shall not be sold for less than par value and accrued interest.

Whenever \$10,000 of such bonds have been issued and sold, authority of issue shall cease, providing that such limit may be increased by a vote of the electors of said city at any general or city election, or special election called

This certificate is made in pursuance of Section 36 of Article 4, of the Constitution of the State of Minnesota, and Chapter 9 of the Revised Laws of 1905 of Minnesota and the acts amendatory thereof and supplementary thereto, and the Charter of said city, and I hereby certify that the recitals in this certificate are true, and that this certificate is made in duplicate.




