




KNOW ALL MEN BY THESE PRESENTS, THAT I, WALTER F. MONDALE, ATTORNEY GENERAL OF THE STATE OF MINNESOTA, BY VIRTUE OF THE AUTHORITY VESTED IN ME BY STATUTE, AND PARTICULARLY BY AUTHORITY OF MINNESOTA STATUTES 1957, SECTION 8.02, DO HEREBY CONSTITUTE AND APPOINT:

FRED C. NORTON

OF ST. PAUL, MINNESOTA, AS SPECIAL ASSISTANT ATTORNEY GENERAL IN THE DEPARTMENT OF TAXATION FOR THE PERIOD COMMENCING MAY 5, 1960, AND TO SERVE AT THE PLEASURE OF THE ATTORNEY GENERAL, OR UNTIL THIS COMMISSION SHALL BE REVOKED OR OTHERWISE TERMINATED IN ACCORDANCE WITH LAW; AND I HEREBY FIX THE COMPENSATION OF SAID FRED C. NORTON AS SUCH SPECIAL ASSISTANT ATTORNEY GENERAL AT THE SUM OF NINE THOUSAND DOLLARS (\$9,000.00) PER YEAR, TO BE PAID FROM THE APPROPRIATION MADE FOR THE DEPARTMENT OF TAXATION.
