ORDINANCE NO. 105

An Ordinance extending the corporate limits of the City of Canby to include certain unplatted land owned by the City of Canby.

SECTION I.

The City of Canby is the owner of the following tracts of land which are located outside the corporate limits of the City of Canby and which are described as follows, to-wit:

Starting at the Northwest corner Block 84 of Canby Land and Lot Company's First Addition Blocks 81 to 87 to City of Canby; thence Southwest along extension of Southeast line of Ring Street 42.7 feet to the point of beginning; thence South 1697 feet; thence West 400 feet; thence North 600 feet; thence Northeast 572 feet along extension of Southeast line of Ring Street to the point of beginning, and containing approximately 8.2 acres.

The Northeast Quarter (NE $\frac{1}{4}$) of Section Thirty-four (34), Township One Hundred Fifteen (115) North, Range Forty-five (45) West, containing 160 acres, more or less.

SECTION II.

The City Council hereby determines (1) that the annexation will be to the best interest of the City of Canby, Minnesota, and of the territory affected; (2) that the territory described herein abuts upon the City and is so conditioned as properly to be subject to City Government.

SECTION III.

The corporate limits of the City are hereby extended to include the property described in Section I and the same is hereby annexed to and included in the City as effectually as if it had originally been a part thereof.

SECTION IV.

The City Recorder is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, the County Auditor, and the Secretary of State.
