ORDINANCE NO. 107

An Ordinance extending the corporate limits of the City of Canby to include certain unplatted land not exceeding 200 acres.

SECTION I.

A petition has been filed with the governing body of the City of Canby, Minnesota, by the sole owner of the following described real estate to have such land included within the City of Canby, Minnesota:

All that part of Section numbered Four (4), Township numbered One Hundred Fourteen (114) North, Range numbered Forty-five (45) West, bounded and described as follows, to-wit: Beginning at a point on the Northwest corner of said Outlet "A" of the 1944 Addition to the City of Canby, according to the revised plat thereof, which point is 400 feet Northeast along the Northwest corner boundary line of said Outlet "A" from the intersection of the Northwest corner boundary line of said Outlet "A" with the Northeast corner boundary line of the highway right-of-way of Trunk Highway No. 68; thence from this starting point Northwest and at right angles to the Northwest corner boundary line of said Outlet "A" a distance of 220 feet; thence at right angles to the last named line Southwest parallel with and distant 220 feet from the Northwest corner line of said Outlet "A" to the Northeast corner line of the highway right-of-way of said Trunk Highway No. 68; thence Northwest along the said Northeast corner line of the highway right-of-way of said Trunk Highway No. 68 to the point where the Northeast corner line of the said highway right-of-way of Trunk Highway No. 68 intersects with the East bank of County Ditch No. 19; thence North along the East bank of said County Ditch No. 19 to the North line of said Section numbered 4; thence due East along the North line of said Section numbered 4 to the Northeast corner of said Section numbered 4; thence due South on the East line of said Section numbered 4 to a point where the East line of said Section numbered 4 intersects with the Northwest corner line of the alley located on the Northwest side of Block Sixty-three (63) of the Swanson's Eighth Addition to the City of Canby, Minnesota; thence Southwest along the Northwest corner line of said alley to a point where the Northwest corner line of said alley intersects with the Northeast corner line of Outlet "B" of the 1944 Addition to the City of Canby, according to the revised plat thereof; thence at right angles and Northwest along the Northeast corner line of said Outlet "B" and continuing along the Northeast corner line of Outlet "A" of the 1944 Addition to the City of Canby, according to the revised plat thereof to the northeast corner of said Outlet "A"; thence at right angles Southwest along the Northwest corner boundary line of said Outlet "A" to the place of beginning.

SECTION II.

The quantity of land embraced within the foregoing description, and bounded as described, is 60 acres, more or less, and does not exceed 200 acres.

SECTION III.

The City Council hereby determines (1) that the annexation will be to the best interest of the City of Canby, Minnesota, and of the territory affected; (2) that the territory described herein abuts upon the City and is so conditioned as properly to be subject to City Government.

SECTION IV.

The corporate limits of the City are hereby extended to include the property described in Section I and the same is hereby annexed to and included in the City as effectually as if it had originally been a part thereof.

SECTION V.

The City Recorder is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, the County Auditor, and the Secretary of State.

SECTION VI.

This Ordinance shall take effect upon its passage and publication and the filing of the certified copies as directed in Section V.
