Ordinance No. 89

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF LAKE CRYSTAL, MINNESOTA, TO INCLUDE CERTAIN PLATTED LAND.

WHEREAS, a certain patition dated July 11th, 1959, requesting annexation of the territory described below, pursuant to Minnesota Statutes Annatated, Section 413.14, was duly presented to the Council on the 20th day of July, 1959.

The Council of the City of Lake Crystal, Minnesota, do ordain as follows:

Section 1. Declaration. It is hereby determined that the territory described below abuts upon the City and is so conditioned as properly to be subjected to City government.

Section 2. Territory annexed. The corporate limits of the City are hereby extended to include the territory described as follows:

> All that part of the Northeast Quarter (NE_4^1) of the Northeast Quarter (NE4) of Section 6, Township 107 North, Range 28 West of the Fifth Principal meridian described as follows, to-wit: Beginning at a point in the East line of said Section 6 distant 50.5 feet Southeasterly measured at right angles from the main track center line of the Chicago, Saint Paul, Minneapolis and Omaha Railway Company, as said main track is now located and established; thence Southwesterly parallel with said main track center line to a point of intersection with the South line to said Northeast Quarter (NE₄) of the Northeast Quarter (NE₄); thence East along said South line of the Northeast Quarter (NE_{4}^{1}) of the Northeast Quarter (NE4) to a point distant 120 feet Southeasterly measured at right angles from said main track center line, said point also being distant 260 feet, more or less, East from the Southwest corner of said Northeast Quarter (NE4) of the Northeast Quarter (NE_4^1) thence Northeasterly on an angle to the left of 27° for a distance of 705 feet to a point of curve; thence on a circular curve, curving to the right, whose radius is 855.37 feet, to the East line of said Section 6; thence North on said East line of Section 6 to the point of beginning. Containing 3.93 acres, more or less.

Section 3. Filing. The City Clerk is hereby directed to file certified copies of this ordinance in the office of the Register of Deeds of Blue Earth County, Minnesota.

Section 4. Effective Date of Annexation. Annexation shall be complete from and after the date when certified copy of this ordinance has been filed as directed in Section 3 and publication.
